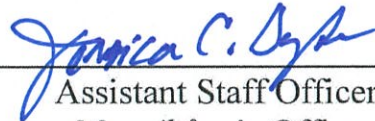

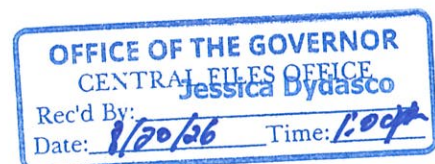

**AN ACT TO *ADD* A NEW § 61531(o) TO CHAPTER 61,
TITLE 21, GUAM CODE ANNOTATED, RELATIVE TO
GRANTING THE DEPARTMENT OF PUBLIC WORKS
TO DETERMINE THE MINIMUM NUMBER OF
PARKING SPACES REQUIRED FOR HOMELESS
SHELTERS.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** A new § 61531(o) is *added* to Chapter 61, Title 21, Guam Code
3 Annotated, to read as follows:

4 “(o) Notwithstanding any other provision of law, the Department of
5 Public Works shall on a case-by-case basis, in permitting the occupancy for
6 structures to be used exclusively as homeless shelters, determine the minimum

1 number of parking spaces for said homeless shelters, however, the minimum
2 number of spaces for persons with disabilities as required by Public Law, shall
3 not be diminished.”
