ENGROSSED HOUSE BILL No. 1091

DIGEST OF HB 1091 (Updated April 6, 2023 8:59 am - DI 140)

Citations Affected: IC 12-15; IC 12-17.6; noncode.

Synopsis: Continuous eligibility under Medicaid and CHIP. Changes the requirements for submitting eligibility information for an individual who is: (1) less than 19 years of age; and (2) a recipient of either the Medicaid program or the children's health insurance program (CHIP) (programs). (Current law concerning the submission of eligibility information in the programs applies to individuals less than three years of age.)

Effective: July 1, 2023.

ENGROSSED HOUSE BILL No. 1091

A BILL FOR AN ACT to amend the Indiana Code concerning human services.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 12-15-2-15.8, AS ADDED BY P.L.218-2007,
2 SECTION 10, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2023]: Sec. 15.8. After an individual who is less than ~~three (3)~~
4 **nineteen (19)** years of age is determined to be eligible for Medicaid
5 under section 14 of this chapter, the individual is not required to submit
6 eligibility information more frequently than once in a twelve (12)
7 month period until the child becomes ~~three (3)~~ **nineteen (19)** years of
8 age.
9 SECTION 2. IC 12-17.6-3-3, AS AMENDED BY P.L.218-2007,
10 SECTION 42, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
11 JULY 1, 2023]: Sec. 3. (a) Subject to subsections (b) and (c), a child
12 who is eligible for the program shall receive services from the program
13 until the earlier of the following:
14 (1) The child becomes financially ineligible.
15 (2) The child becomes nineteen (19) years of age.
16 (b) Subsection (a) applies only if the child and the child's family
17 comply with enrollment requirements.

1 (c) After a child who is less than ~~three (3)~~ **nineteen (19)** years of
2 age is determined to be eligible for the program, the child is not

6 SECTION 3. [EFFECTIVE JULY 1, 2023] (a) **Before September**
7 **1, 2023, the office of the secretary of family and social services shall**
8 **apply for any state plan amendment or Medicaid waiver necessary**
9 **to change the age set forth in IC 12-15-2-15.8, as amended by this**
10 **act, concerning continuous eligibility for the Medicaid program**
11 **from a Medicaid recipient who is less than three (3) years of age to**
12 **a Medicaid recipient who is less than nineteen (19) years of age.**

13 (b) **Before September 1, 2023, the office of Medicaid policy and**
14 **planning shall apply for any federal approval necessary to change**
15 **the age set forth in IC 12-17.6-3-3, as amended by this act,**
16 **concerning continuous eligibility for the children's health**
17 **insurance program from a recipient who is less than three (3) years**
18 **of age to a recipient who is less than nineteen (19) years of age.**

19 (c) **This SECTION expires December 31, 2023.**
