MR. SPEAKER:

I move that House Bill 1428 be amended to read as follows:

- 1 Page 1, between lines 10 and 11, begin a new paragraph and insert:
- 2 "SECTION 3. IC 3-5-6-7.1 IS ADDED TO THE INDIANA CODE
- 3 AS A **NEW SECTION TO READ AS FOLLOWS [EFFECTIVE**
- 4 **JANUARY 1, 2024]: Sec. 7.1. (a) This section applies:**
- 5 **(1) when a:**
- 6 **(A) declaration of candidacy;**
- 7 **(B) petition of nomination;**
- 8 **(C) petition for nomination of a candidate for delegate to**
- 9 **a convention under IC 3-10-5-7;**
- 10 **(D) petition for the placement of a local public question on**
- 11 **the ballot;**
- 12 **(E) petition by a voter who desires a recount under**
- 13 **IC 3-12-12-2;**
- 14 **(F) petition requesting the establishment of a community**
- 15 **school corporation under IC 20-23-4-20;**
- 16 **(G) remonstrance under IC 20-23-5;**
- 17 **(H) petition requesting that a school corporation**
- 18 **consolidate with another school corporation under**
- 19 **IC 20-23-7-2;**
- 20 **(I) petition under IC 20-23-8-10;**
- 21 **(J) petition under IC 20-23-8-14;**
- 22 **(K) remonstrance under IC 20-23-10-7;**

- 1 **(L) nomination petition under IC 20-23-12-5; or**
- 2 **(M) petition, declaration, or other filing that:**
- 3 **(i) is not otherwise listed in clauses (A) through (L); and**
- 4 **(ii) seeks to place an item for consideration on an election**
- 5 **ballot;**
- 6 **must be signed by or accompanied by a petition signed by one**
- 7 **(1) or more voters; and**
- 8 **(2) when the signatures described in subdivision (1) must be**
- 9 **certified or otherwise approved by the person with whom the**
- 10 **document is filed.**
- 11 **(b) An individual may file one (1) or more of the signatures**
- 12 **described by subsection (a)(1):**
- 13 **(1) not:**
- 14 **(A) earlier than the first date; and**
- 15 **(B) later than the last date;**
- 16 **on which the document listed in subsection (a) may be filed;**
- 17 **(2) with the person with whom the document must be filed;**
- 18 **and**
- 19 **(3) for the purpose of receiving a determination under**
- 20 **subsection (c).**
- 21 **(c) Not later than seven (7) days after an individual makes a**
- 22 **filing under subsection (b), the person with whom the document**
- 23 **must be filed shall transmit to the individual who filed the**
- 24 **document a written determination indicating the number of**
- 25 **signatures submitted under subsection (b) that:**
- 26 **(1) will not count toward the number of signatures required**
- 27 **for the document; and**
- 28 **(2) will count toward the number of signatures required for**
- 29 **the document.**
- 30 **(d) A filing made under subsection (b) does not modify the**
- 31 **deadline by which a document described in subsection (a)(1) must**
- 32 **be filed."**
