DIGEST OF PROPOSED AMENDMENT

Scholarship regarding transition to teaching. Removes the requirement that, to qualify for a next generation Hoosier educators scholarship regarding a transition to teaching program, an applicant must be employed by a school corporation in Indiana.

A BILL FOR AN ACT to amend the Indiana Code concerning higher education.

Be it enacted by the General Assembly of the State of Indiana:
