DIGEST OF SB 3 (Updated April 13, 2023 4:07 pm - DI 119)

Citations Affected: Noncode.

Synopsis: State and local tax review task force. Establishes the state and local tax review task force (task force). Specifies the membership of the task force and provides for the selection of the chairperson and vice chairperson of the task force. Specifies the topics the task force is required to review and requires the task force to submit the task force's findings and recommendations to the legislative council not later than December 1, 2023.

Effective: Upon passage.

A BILL FOR AN ACT concerning taxation and to make an appropriation.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. [EFFECTIVE UPON PASSAGE] (a) **As used in this**

15 **who is a member of the majority party of the house, appointed**

21 and submit a report to the legislative council, in an electronic
22 format under IC 5-14-6, that sets forth the topics reviewed by the
23 task force and the task force's findings and recommendations.
- 24 (l) This SECTION expires June 30, 2024.
- 25 SECTION 2. An emergency is declared for this act.

(f) Each member of the task force who is not a state employee is entitled to receive the same per diem, mileage, and travel allowances paid to individuals who serve as legislative and lay members, respectively, of interim study committees established by the legislative council. The expenses described in this subsection must be paid from money appropriated to the legislative council for the use of the task force."

The amount appropriated by this SECTION is allocated as follows:

(1) One hundred thousand dollars (\$100,000) for the state fiscal year beginning July 1, 2023, and ending June 30, 2024.

(2) One hundred thousand dollars (\$100,000) for the state fiscal year beginning July 1, 2024, and ending June 30, 2025.

Amounts appropriated by this SECTION must be used to pay the state and local tax review task force's expenses.

(b) This SECTION expires July 1, 2025."

Madam President: I move that Senate Bill 3 be amended to read as follows:

Page 2, delete lines 20 through 26, begin a new paragraph and insert:

"(f) The following apply to the mileage, per diem, and travel expenses for members of the task force:

(1) Each member of the task force who is a state employee is entitled to reimbursement for traveling expenses as provided under IC 4-13-1-4 and other expenses actually incurred in connection with the member's duties as provided in the state policies and procedures established by the Indiana department of administration and approved by the budget agency.

(2) Each member of the task force who is a member of the general assembly or who is not a state employee is entitled to receive the same per diem, mileage, and travel allowances paid to individuals who serve as legislative and lay members, respectively, of interim study committees established by the legislative council."

Page 2, line 11, after "appointed" insert **"jointly"**.

Page 2, line 11, delete "senate." and insert **"senate and the speaker of the house of representatives."**

Page 2, delete lines 15 through 19, begin a new paragraph and insert:

"(e) Not later than July 1, 2023, the:

(1) chairperson of the legislative council shall select a member of the task force to serve as the chairperson of the task force; and

(2) vice chairperson of the legislative council shall select a member of the task force to serve as the vice chairperson of the task force.

The members selected under subdivisions (1) and (2) shall serve as chairperson and vice chairperson until January 1, 2024. Beginning January 1, 2024, the member initially appointed under subdivision (2) shall instead serve as the chairperson of the task force, and the member initially appointed under subdivision (1) shall instead serve as the vice chairperson of the task force."

Page 2, delete lines 36 through 42, begin a new line block indented and insert:

"(1) The state's near term and long term financial outlook and overall fiscal position.

(2) The state's appropriation backed debt obligations.

(3) The funded status of pension funds managed by the state, including methods to reduce the unfunded actuarial accrued liability of the pre-1996 account within the Indiana state teachers' retirement fund.

(4) The individual income tax, including methods to reduce or eliminate the individual income tax.

(5) The corporate income tax.

(6) The state gross retail and use tax, including a review of the state gross retail tax base.

(7) The property tax, including methods to reduce or eliminate the tax on homestead properties and reduce or eliminate the tax on business personal property.

(8) Local option taxes, including the local income tax, food and beverage taxes, and innkeeper's taxes."
