Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. [EFFECTIVE UPON PASSAGE] (a) As used in this	
2	SECTION, "task force" refers to the state and local tax review task

4	(b) The state and local tax review task force is established.	
5	(c) The task force consists of the following members:

9	liability of the pre-1996 account within the Indiana state	
10	teachers' retirement fund.	
11	(4) The individual income tax, including methods to reduce

14	(6) The state gross retail and use tax, including a review of	
15	the state gross retail tax base.	
16	(7) The property tax, including methods to reduce or	
17	eliminate the tax on homestead properties and reduce or

19	(8) Local option taxes, including the local income tax, food	
20	and beverage taxes, and innkeeper's taxes.	
21	(h) The legislative services agency shall provide staff support	
22	to the task force.	
23	(i) The meetings of the task force must be held in public as	
24	provided under IC 5-14-1.5. However, the task force is permitted	
25	to meet in executive session as determined necessary by the	
26	chairperson of the task force.	
27	(j) The task force shall meet at least four (4) times in calendar	
28	year 2023, and at least four (4) times in calendar year 2024 at the	
29	call of the chairperson.	
30	(k) On or before December 1, 2024, the task force shall	
31	prepare and submit a report to the legislative council, in an	
32	electronic format under IC 5-14-6, that sets forth the topics	
33	reviewed by the task force and the task force's findings and	
34	recommendations.	
35	(1) This SECTION expires June 30, 2025.
