# SENATE BILL No. 303

A BILL FOR AN ACT to amend the Indiana Code concerning business and other associations.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 23-17-32 IS ADDED TO THE INDIANA CODE  
 2 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE  
 3 JULY 1, 2023]:  
 4 **Chapter 32. Nonprofit Organizations: Privacy Protections for**  
 5 **Members, Volunteers, and Donors**  
 6 **Sec. 1. This chapter does not apply to:**  
 7 **(1) a national securities association that is registered:**  
 8 **(A) under Section 15(a) of the Securities Exchange Act**  
 9 **of 1934 (15 U.S.C. 78o-3); and**  
 10 **(B) in accordance with any regulations adopted under**  
 11 **the Securities Exchange Act of 1934 (15 U.S.C. 78a et**  
 12 **seq.); or**  
 13 **(2) any information a national securities association**  
 14 **described in subdivision (1) provides to the secretary of state**  
 15 **under IC 23-19 or under rules adopted or orders issued**



- 1           under IC 23-19.
- 2           **Sec. 2. As used in this chapter, "nonprofit organization"**
- 3 **means one (1) of the following:**
- 4           **(1) A domestic corporation (as defined in IC 23-17-2-11).**
- 5           **(2) A foreign corporation (as defined in IC 23-17-2-13).**
- 6           **(3) An entity that is exempt from federal income tax under**
- 7 **Section 501(c) of the Internal Revenue Code.**
- 8           **(4) An entity that has submitted an application with the**
- 9 **Internal Revenue Service for recognition of an exemption**
- 10 **under Section 501(c) of the Internal Revenue Code.**
- 11          **Sec. 3. As used in this chapter, "person" has the meaning set**
- 12 **forth in IC 23-17-2-20.**
- 13          **Sec. 4. As used in this chapter, "personal information" means**
- 14 **any compilation of data (including any list, record, registry, roll, or**
- 15 **roster) that directly or indirectly identifies a person as a:**
- 16           **(1) member of;**
- 17           **(2) supporter of;**
- 18           **(3) volunteer for; or**
- 19           **(4) donor of financial or nonfinancial support to;**
- 20 **a nonprofit organization.**
- 21          **Sec. 5. As used in this chapter, "public agency" means a:**
- 22           **(1) state agency (as defined in IC 1-1-15-3); or**
- 23           **(2) political subdivision (as defined in IC 36-1-2-13).**
- 24          **Sec. 6. (a) Except as provided in subsection (b), a public agency**
- 25 **shall not do any of the following:**
- 26           **(1) Either:**
- 27               **(A) require any person or nonprofit organization to**
- 28               **provide the public agency with personal information; or**
- 29               **(B) otherwise compel the release of personal**
- 30               **information.**
- 31           **(2) Release, publicize, or otherwise publicly disclose personal**
- 32           **information in the possession of the public agency.**
- 33           **(3) Request or require a current or prospective:**
- 34               **(A) contractor for; or**
- 35               **(B) grantee of;**
- 36           **the public agency to provide a list of nonprofit organizations**
- 37           **to which the current or prospective contractor or grantee**
- 38           **has provided financial or nonfinancial support.**
- 39          **(b) Subsection (a) does not apply with respect to any of the**
- 40 **following:**
- 41           **(1) Any report or disclosure required under state:**
- 42               **(A) campaign finance law as required by IC 3-9-5; or**

- 1 (B) lobbying disclosure law as required by IC 2-7.
- 2 (2) A lawful order or warrant, issued by a court of competent
- 3 jurisdiction, for the provision, disclosure, or release of
- 4 personal information.
- 5 (3) A lawful request for discovery of personal information in
- 6 the context of litigation if the following conditions are met:
- 7 (A) The requesting party or person demonstrates, by
- 8 clear and convincing evidence, as determined by the
- 9 court, a compelling need for the personal information.
- 10 (B) The requesting party or person obtains a protective
- 11 order, issued by the court, barring disclosure of the
- 12 personal information to any person not named as a
- 13 party in the litigation.
- 14 (4) Admission of personal information as relevant evidence
- 15 before a court of competent jurisdiction. However, a court
- 16 may not publicly disclose or release personal information
- 17 without a specific finding of good cause.
- 18 (5) Release by a public agency of personal information that
- 19 was voluntarily released by:
- 20 (A) the person to whom the personal information
- 21 pertains; or
- 22 (B) the nonprofit organization with which the personal
- 23 information is associated;
- 24 to the public.
- 25 (6) A collection of information that:
- 26 (A) includes the identity of any director, officer,
- 27 registered agent, or incorporator of a nonprofit
- 28 organization; and
- 29 (B) is part of any report or disclosure required to be
- 30 filed with the secretary of state under this article or any
- 31 other statute.
- 32 However, information that directly identifies a person as a
- 33 donor of financial support to a nonprofit organization shall
- 34 not be collected by or disclosed to the secretary of state.
- 35 (7) Disclosure of personal information that is derived from
- 36 a financial donation to a nonprofit organization that is
- 37 affiliated with a public agency if:
- 38 (A) the disclosure is required by statute; and
- 39 (B) the person to whom the personal information
- 40 pertains has not previously made a request for
- 41 anonymity to the nonprofit organization.
- 42 (c) Personal information is considered confidential and is not

1 subject to disclosure under IC 5-14-3.  
 2 Sec. 7. (a) A person alleging a violation of this chapter may  
 3 bring a civil action in a court of competent jurisdiction for either  
 4 or both the following:  
 5 (1) Injunctive relief.  
 6 (2) Damages as follows:  
 7 (A) a sum of money:  
 8 (i) to be determined by the court; but  
 9 (ii) not less than two thousand five hundred dollars  
 10 (\$2,500);  
 11 per violation to compensate the person for injury or loss  
 12 caused by the violation; or  
 13 (B) if the court finds that the violation was intentional,  
 14 an increased sum of money in an amount not to exceed  
 15 three (3) times the amount that would otherwise be  
 16 awarded under clause (A).  
 17 (b) A court, in rendering a judgment in an action brought  
 18 under this section, may award all or part of the costs of the action,  
 19 including reasonable attorney's fees and witness fees, to the  
 20 complainant in the action if the court determines that the award is  
 21 appropriate.  
 22 Sec. 8. Any:  
 23 (1) public employee;  
 24 (2) public official; or  
 25 (3) employee or officer of a:  
 26 (A) contractor; or  
 27 (B) subcontractor;  
 28 of a public agency;  
 29 who violates this chapter is subject to penalties and discipline set  
 30 forth in IC 5-14-3-10.
