## HOUSE MOTION \_\_\_\_\_

MR. SPEAKER:

I move that House Bill 1002 be amended to read as follows:

1       Page 8, line 1, delete "(h), an electric or gas utility may not  
2       terminate" and insert "**(i), the following apply with respect to the**  
3       **termination of residential electric or gas service:**  
4       **(1) An electric or gas utility may not terminate residential**  
5       **electric or gas service** from December 1 through March 15 of  
6       any year no electric or gas utility, including a municipally owned,  
7       privately owned, or cooperatively owned utility, shall terminate  
8       residential electric or gas service for persons **customers** who are  
9       eligible for and have applied for assistance from a heating  
10      assistance program administered under IC 4-4-33.  
11      **(2) Subject to subsection (d), on any day for which a local**  
12      **weather forecast office of the National Weather Service has**  
13      **forecast, not earlier than forty-eight (48) hours in advance, a**  
14      **heat index of at least ninety-five (95) degrees Fahrenheit for**  
15      **a county or region within an electric utility's assigned service**  
16      **area under IC 8-1-2.3, the electric utility may not terminate**  
17      **residential electric service for customers who:**  
18       **(A) receive residential electric service from the electric**  
19       **utility at a location to which the forecasted heat index**  
20       **applies; and**  
21       **(B) are eligible for and have applied for assistance under**  
22       **a heating assistance program administered under**

1                   **IC 4-4-33 during the calendar year in which the forecast is**  
2                   **made.**

3                   **For purposes of subdivision (1), the commission shall implement**  
4                   **procedures to ensure that electric or gas utility service is continued**  
5                   **while eligibility for such persons customers is being determined.**

6                   **(d) If:**

7                   **(1) an electric utility has provided a notice of disconnection to**  
8                   **a customer described in subsection (c)(2) before the local**  
9                   **weather forecast office of the National Weather Service**  
10                  **forecasts a heat index described in subsection (c)(2) for the**  
11                  **customer's service location; and**  
12                  **(2) the fourteen (14) day period following the issuance of the**  
13                  **disconnection notice during which the electric utility is**  
14                  **prohibited from terminating the customer's electric service**  
15                  **under 170 IAC 4-1-16 has not elapsed on the date the forecast**  
16                  **is made;**

17                  **the fourteen (14) day period described in subdivision (2) is tolled**  
18                  **for a period beginning on the date on which the forecasted heat**  
19                  **index described in subsection (c)(2) is made by the local weather**  
20                  **forecast office of the National Weather service and ending at 11:59**  
21                  **p.m. on the first day that follows the day with respect to which the**  
22                  **forecast was made and during which the forecasted heat index is**  
23                  **not reached.**".
