



SENATE MOTION

MR. PRESIDENT:

I move that Engrossed House Bill 1002 be amended to read as follows:

- 1 Page 4, between lines 30 and 31, begin a new paragraph and insert:
2 "SECTION 3. IC 8-1-2-4.9 IS ADDED TO THE INDIANA CODE
3 AS A **NEW SECTION TO READ AS FOLLOWS [EFFECTIVE**
4 **UPON PASSAGE]: Sec. 4.9. (a) This section applies to a base rate**
5 **case:**
6 **(1) that is filed by an electricity supplier with the commission;**
7 **and**
8 **(2) with respect to which the commission has not issued a final**
9 **order before March 15, 2026;**
10 **regardless of when the base rate case is filed by the electricity**
11 **supplier with the commission.**
12 **(b) As used in this section, "electricity supplier" means a**
13 **person, however organized, that:**
14 **(1) provides retail electric service to customers in Indiana;**
15 **and**
16 **(2) is under the jurisdiction of the commission for the**
17 **approval of rates and charges.**
18 **(c) After March 14, 2026, the commission may not issue a final**
19 **order in a base rate case filed by an electricity supplier if the final**
20 **order, once fully implemented, would result in an average increase**

- 1 **of three percent (3%) or greater in the total monthly bill of a**
- 2 **residential customer of the electricity supplier."**
- 3 Renumber all SECTIONS consecutively.
