Proposed Changes to introduced printing by AM100218

### DIGEST OF PROPOSED AMENDMENT

Utility disconnections. Replaces provisions regarding utility disconnections during extreme heat warnings with a provision prohibiting an electric or gas utility from terminating residential electric or gas service from June 1 through September 23 for customers who are eligible for and have applied for assistance from a heating assistance program.

A BILL FOR AN ACT to amend the Indiana Code concerning utilities.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 8-1-2-4.7 IS ADDED TO THE INDIANA CODE  
2 AS A **NEW SECTION TO READ AS FOLLOWS [EFFECTIVE**  
3 **UPON PASSAGE]: Sec. 4.7. (a) As used in this section, "budget**  
4 **billing plan" means a leveled payment plan, however**  
5 **denominated, that:**  
6 **(1) applies to a customer's account with an electricity**  
7 **supplier;**  
8 **(2) provides for the payment of a customer's bill in equal**  
9 **monthly installments; and**  
10 **(3) involves a reconciliation mechanism in which:**  
11 **(A) the amount of utility service actually used by the**  
12 **customer during a specified period is compared with the**  
13 **amount of utility service for which the customer was**  
14 **billed under the plan during the specified period; and**

**(C) the method by which the electricity supplier will:**

(i) compare the amount of utility service actually used by the customer with the amount of utility service for which the customer was billed under the plan during the billing cycles that are being reconciled; and

(ii) either bill or credit the customer's account, as appropriate, for any difference identified under item (i);

(b) The public utility shall update the public utility's TDSIC plan under subsection (a)(2) at least annually. An update may include a petition for approval of:

(1) a targeted economic development project under section 11 of this chapter; or

(2) transmission, distribution, and storage system improvements not described in the public utility's TDSIC plan most recently approved by the commission under section 10 of this chapter.

(c) A public utility that recovers capital expenditures and TDSIC costs under subsection (a) shall defer the remaining twenty percent (20%) of approved capital expenditures and TDSIC costs, including depreciation, allowance for funds used during construction, and post in service carrying costs, and shall recover those capital expenditures and TDSIC costs as part of the next general rate case that the public utility files with the commission.

(d) Except as provided in section 15 of this chapter, a public utility may not file a petition under subsection (a) within nine (9) months after the date on which the commission issues an order changing the public utility's basic rates and charges with respect to the same type of utility service.

(e) This subsection does not apply to an electricity supplier (as defined in IC 8-1-46-6) that:

- (1) is subject to a multi-year rate plan under IC 8-1-46; or
- (2) petitions the commission for approval of a multi-year rate plan under IC 8-1-46;

**during the term of the electricity supplier's approved TDSIC plan.** [ ] A public utility that implements a TDSIC under this chapter shall, before the expiration of the public utility's approved TDSIC plan, petition the commission for review and approval of the public utility's basic rates and charges with respect to the same type of utility service.

 7           year, to all customers receiving retail electric service under the  
 8           electricity supplier's standard residential tariff.

9           (b) The term includes the following charges:

10           (1) Fixed service charges.

11           (2) Energy charges based on the amount of electricity  
 12           provided to or consumed by the customer during the billing  
 13           cycle.

14           (3) Additional charges or credits, including any applicable  
 15           rate adjustment mechanisms approved by the commission.

16           (4) Taxes.

17           Sec. 2. As used in this chapter, "commission" refers to the  
 18           Indiana utility regulatory commission created by IC 8-1-1-2.

19           Sec. 3. (a) As used this chapter, "customer", with respect to an  
 20           electricity supplier, means a metered electrical service point:

21           (1) that is located at a specific location in Indiana; and  
 22           (2) for which an active billing account is established by the  
 23           electricity supplier.

24           (b) As the context requires, the term includes the person of  
 25           record who has agreed to pay for the retail electric service  
 26           provided by the electricity supplier at the location described in

28           Sec. 4. As used in this chapter, "customer affordability

 17      mechanism", or "PIM", means a ratemaking mechanism that is  
 18      approved by the commission and that:

19               (1) links an electricity supplier's earnings to the electricity  
 20               supplier's performance in targeted areas that are consistent  
 21               with the provision of electric utility service with the  
 22               attributes set forth in IC 8-1-2-0.6, including:

23                       (A) reliability;  
 24                       (B) affordability;  
 25                       (C) resiliency;  
 26                       (D) stability; and  
 27                       (E) environmental sustainability;

  - 32       **(B) communicated to customers in advance.**

 20 forecasts over all or any part of the twelve (12) month period on  
 21 which the electricity supplier's petition is based, subject to the  
 22 commission's consideration of the electricity supplier's historical  
 23 forecasting accuracy. If forecasted data is used, the proposed rate  
 24 schedule must provide for a reconciliation mechanism to correct  
 25 for any variance between the forecasted eligible program costs and  
 26 the actual eligible program costs incurred.

27 (c) Subject to subsection (d), after reviewing an electricity  
 28 supplier's petition under subsection (a)(2), the commission  
 29 determines that:

30 (1) the electricity supplier has incurred or will incur eligible  
 31 program costs that are reasonable in amount;  
 32 (2) notwithstanding section 10 of this chapter, the effect or  
 33 the potential effect, in both the long and short term, of the  
 34 proposed rate schedule on the electric rates of  
 35 nonparticipating customers or other customer classes of the  
 36 electricity supplier will be minimal; and  
 37 (3) approval of the proposed rate schedule is in the public  
 38 interest;

39 the commission shall approve the electricity supplier's proposed  
 40 rate schedule under subsection (b).

41 (d) The commission may not approve a rate schedule under  
 42 subsection (b) that would result in an average aggregate increase



1       in an electricity supplier's total retail revenues of more than two  
 2       percent (2%) with respect to the twelve (12) month period on  
 3       which the electricity supplier's proposed rate schedule is based. If  
 4       an electricity supplier incurs eligible program costs in connection  
 5       with the electricity supplier's low income customer assistance  
 6       program that exceed the limit set forth in this subsection, the  
 7       electricity supplier may seek to recover those eligible program  
 8       costs for recovery in the electricity supplier's next base rate case.

9       **Sec. 10.** A low income customer assistance program offered  
 10      under this chapter that affects rates and charges for service is not  
 11      discriminatory for purposes of this chapter or any other law  
 12      regulating rates and charges for service.

13      **Sec. 11.** (a) Beginning in 2027, the commission shall include in  
 14      the annual report that the commission is required to submit under  
 15      IC 8-1-1-14 before October 1 of each year the following  
 16      information for each electricity supplier with respect to the most  
 17      recently concluded state fiscal year:

18       (1) The number of low income customers enrolled in the  
 19       electricity supplier's low income customer assistance  
 20       program at the beginning and end of the state fiscal year.

21       (2) The total amount of assistance provided to low income  
 22       customers under the electricity supplier's program.

23       (3) The median amount of assistance provided to each  
 24       customer under the electricity supplier's program.

25       (4) Subject to subsection (c), an identification of the sources  
 26       and amounts of any money, services, or property contributed  
 27       to the electricity supplier's program by or through:

28           (A) governmental agencies or programs; or

29           (B) other third parties, including voluntary charitable  
 30           contributions from nonprofit organizations or from  
 31           employees, customers, or shareholders of the electricity  
 32           supplier.

33       (5) An identification of the amounts of any:

34           (A) per customer funding limits;

35           (B) enrollment limits; or

36           (C) other limits, caps, or restrictions;

37       established by the electricity supplier under section 5(b) of  
 38       this chapter, along with information as to whether and when  
 39       any such limits, caps, or restrictions were reached or applied  
 40       during the state fiscal year.

41       (b) Subject to subsection (c), an electricity supplier shall  
 42       provide the commission, at the time and in the manner prescribed



1 by the commission, any information required under subsection (a)  
 2 to be included in the commission's annual report.

3 (c) Upon request by an electricity supplier, the commission  
 4 shall determine whether any information and related materials  
 5 described in subsection (a):

- 6 (1) are confidential under IC 5-14-3-4;
- 7 (2) are exempt from public access and disclosure by Indiana  
   8 law; and
- 9 (3) must be treated as confidential and protected from public  
   10 access and disclosure by the commission.

11 In addition, an electricity supplier is not required to name  
 12 individual third party donors under subsection (a)(4) and may  
 13 instead report the types of third party organizations and  
 14 individuals that contributed to the electricity supplier's program  
 15 and the amounts contributed by each type.

16 Sec. 12. The commission shall adopt rules under IC 4-22-2 to  
 17 implement this chapter.

18 SECTION 7. [EFFECTIVE UPON PASSAGE] (a) As used in this  
 19 SECTION, "commission" refers to the Indiana utility regulatory  
 20 commission created by IC 8-1-1-2.

21 (b) Not later than May 1, 2026, the commission shall amend  
 22 the following rules of the commission as necessary to conform the  
 23 rules with IC 8-1-2-121, as amended by this act:

- 24 (1) 170 IAC 4.
- 25 (2) 170 IAC 5.
- 26 (3) Any other rule that:
  - 27 (A) has been adopted by the commission; and
  - 28 (B) is inconsistent with IC 8-1-2-121, as amended by this  
   29 act.

30 (c) This SECTION expires January 1, 2027.

31 SECTION 8. [EFFECTIVE UPON PASSAGE] (a) Before  
 32 January 1, 2027, the commission shall amend 170 IAC 4-1-23 as  
 33 necessary to conform 170 IAC 4-1-23 to the requirements of  
 34 IC 8-1-46, as added by this act.

35 (b) This SECTION expires January 2, 2027.
