## HOUSE MOTION \_\_\_\_\_

MR. SPEAKER:

I move that House Bill 1003 be amended to read as follows:

- 1 Page 7, between lines 41 and 42, begin a new paragraph and insert:
- 2 "Sec. 2.5. As used in this chapter, "department" refers to the
- 3 Indiana state department of agriculture established by
- 4 IC 15-11-2-1."
- 5 Page 8, delete lines 8 through 19, begin a new paragraph and insert:
- 6 "(b) The task force consists of thirteen (13) voting members and
- 7 three (3) nonvoting members appointed as follows:
- 8 (1) Two (2) members of the senate appointed by the president
- 9 pro tempore of the senate.
- 10 (2) One (1) member of the senate appointed by the minority
- 11 leader of the senate.
- 12 (3) Two (2) members of the house of representatives
- 13 appointed by the speaker of the house of representatives.
- 14 (4) One (1) member of the house of representatives appointed
- 15 by the minority leader of the house of representatives.
- 16 (5) Seven (7) members appointed by the governor as follows:
- 17 (A) One (1) member representing Indiana Farm Bureau.
- 18 (B) One (1) member engaged in poultry production.
- 19 (C) One (1) member engaged in dairying.
- 20 (D) One (1) member engaged in beef-type cattle
- 21 production.
- 22 (E) One (1) member engaged in swine production.

- 1 (F) One (1) member engaged in corn production.  
 2 (G) One (1) member engaged in soybean production.  
 3 (6) The director of the state department of agriculture who  
 4 serves ex officio and is a nonvoting member.  
 5 (7) The dean of the College of Agriculture of Purdue  
 6 University who serves ex officio and is a nonvoting member.  
 7 (8) The dean of the College of Veterinary Medicine of Purdue  
 8 University who serves ex officio and is a nonvoting member.  
 9 The voting members appointed under subdivisions (1) through (5)  
 10 serve at the pleasure of the appointing authority.".  
 11 Page 8, delete lines 34 through 42, begin a new paragraph and  
 12 insert:  
 13 "Sec. 7. The task force shall study the following aspects of  
 14 transferring the administration and functions of the office of the  
 15 state chemist, the state egg board, and the creamery examining  
 16 board from Purdue University to the department:  
 17 (1) Employment issues arising from a transfer of  
 18 administration and functions of the offices described in this  
 19 section from Purdue University to the department.  
 20 (2) Issues arising from a transfer of any property, records,  
 21 funds, or accounts from Purdue University to the department.  
 22 (3) The feasibility of transferring administration and  
 23 functions of the offices described in this section from Purdue  
 24 University to the department."  
 25 Page 161, delete lines 29 through 42.  
 26 Delete pages 162 through 169.  
 27 Page 170, delete lines 1 through 6, begin a new paragraph and  
 28 insert:  
 29 "SECTION 280. IC 16-18-2-37.5, AS AMENDED BY P.L.3-2008,  
 30 SECTION 103, IS AMENDED TO READ AS FOLLOWS  
 31 [EFFECTIVE JULY 1, 2026]: Sec. 37.5. (a) "Board", for purposes of  
 32 IC 16-22-8, has the meaning set forth in IC 16-22-8-2.1.  
 33 (b) "Board", for purposes of IC 16-41-42.2, has the meaning set  
 34 forth in IC 16-41-42.2-1."  
 35 Page 195, delete lines 19 through 42.  
 36 Delete pages 196 through 201.  
 37 Page 202, delete lines 1 through 39.  
 38 Page 452, delete lines 21 through 38.  
 39 Renumber all SECTIONS consecutively.
