DIGEST OF PROPOSED AMENDMENT

Autism information. Removes a provision from the bill that repealed language concerning the distribution of autism information to noncertificated employees.

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 5-1-11.5-3, AS ADDED BY P.L.244-2017,
2 SECTION 2, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2026]: Sec. 3. (a) This section applies only to a school
4 corporation that has an ADM of more than fifteen thousand (15,000)
5 for the school corporation's most recent fall count. Notwithstanding any
6 other law, a school corporation subject to this section may not issue
7 bonds after August 15, 2020, unless the school corporation has for its
8 preceding budget year prepared an annual financial report using the
9 modified accrual basis of accounting in accordance with generally
10 accepted accounting principles. However, upon request of a school
11 corporation to the state examiner, the state examiner may waive the
12 requirement under this section if the state examiner determines that a
13 waiver is in the best interest of the school corporation.

14 **(b) If a school corporation described in subsection (a) uses the**
15 **accounting described in subsection (a), the school corporation may**
16 **not be required to use another form of accounting.**

Sec. 8. A grant received by a school corporation may be expended by the school corporation for a twenty-four (24) month period.

Sec. 9. The department shall develop guidelines necessary to implement this chapter.

Chapter 8. Early Childhood Programs

Sec. 1. As used in this chapter, "early childhood program" refers to a voluntary parental education program for parents of children from birth to less than three (3) years of age that provides these parents with information and activities to help the parents better prepare children for school.

17 **Chapter 9. Alternative Education Program Grants**

18 **Sec. 1.** As used in this chapter, "alternative education
 19 program" means an alternative education program (as defined in

21 **Sec. 2.** As used in this chapter, "full-time equivalent students"
 22 means the number of students determined under IC 20-30-8-16.

23 **Sec. 3.** As used in this chapter, "qualifying school corporation"

27 **Sec. 4.** A qualifying school corporation is eligible to receive a
 28 grant from the state for each full-time equivalent student who is

31 **Sec. 5.** The maximum amount that may be granted to a
 32 qualifying school corporation in a school year is seven hundred
 33 fifty dollars (\$750) per full-time equivalent student.

34 **Sec. 6.** To receive a grant under this chapter, a school
 35 corporation must expend on alternative education programs in the
 36 school year a matching amount of at least one-third (1/3) of the
 37 amount of the state grant per full-time equivalent student, as
 38 determined under the rules adopted by the state board.

39 **Sec. 7. (a)** Except as provided in subsection (b), the department
 40 shall distribute a grant under this chapter to a qualifying school
 41 corporation not later than September 1. The grant must be for the
 42 number of full-time equivalent students enrolled in and attending

22 (as defined in IC 20-35-9-3) and incorporated into a student's
23 individualized education program (as defined in IC 20-18-2-9) and
24 that describes the following:

- 25 (1) The pattern of behavior that impedes the student's
26 learning or the learning of others.
- 27 (2) The purpose or function of the behavior as identified in
28 a functional behavioral assessment.
- 29 (3) The positive interventions and supports, and other
30 strategies, to:
 - 31 (A) address the behavior; and
 - 32 (B) maximize consistency of implementation across
33 people and settings in which the student is involved.
- 34 (4) If applicable, the skills that will be taught and monitored
35 in an effort to change a specific pattern of behavior of the
36 student.

37 The behavioral intervention plan seeks to maximize consistency of
38 implementation across people and settings in which the student is
39 involved.

40 Sec. 2. As used in this chapter, "chemical restraint" means the
41 administration of a drug or medication to manage a student's
42 behavior or restrict a student's freedom of movement that is not a

- 9 (2) a material; or
- 10 (3) equipment;

11 attached or adjacent to a student's body that the student cannot
12 remove and that restricts the freedom of movement of all or part
13 of the student's body or restricts normal access to the student's
14 body.

15 (b) The term does not include:

- 16 (1) mechanical devices;
- 17 (2) a material; or
- 18 (3) equipment;

19 used as prescribed by a doctor.

20 Sec. 5. (a) As used in this chapter, "physical restraint" means
21 physical contact between a school employee and a student:

- 22 (1) in which the student unwillingly participates; and
- 23 (2) that involves the use of a manual hold to restrict freedom
24 of movement of all or part of a student's body or to restrict
25 normal access to the student's body.

26 (b) The term does not include:

- 27 (1) briefly holding a student without undue force in order to
28 calm or comfort the student, or to prevent unsafe behavior,
29 such as running into traffic or engaging in a physical
30 altercation;
- 31 (2) physical escort; or
- 32 (3) physical contact intended to gently assist or prompt a
33 student in performing a task or to guide or assist a student
34 from one (1) area to another.

35 Sec. 6. As used in this chapter, "positive behavior intervention
36 and support" means a systematic approach that:

- 37 (1) uses evidence based practices and data driven decision
38 making to improve school climate and culture; and
- 39 (2) includes a range of systematic and individualized
40 strategies to reinforce desired behavior and diminish
41 reoccurrence of problem behavior;

42 to achieve improved academic and social outcomes and increase

2 Sec. 7. As used in this chapter, "school corporation" includes
3 a charter school that is not a virtual charter school.

4 Sec. 8. As used in this chapter, "school employee" means an
5 individual employed by a school corporation or a state accredited
6 nonpublic school.

7 Sec. 9. As used in this chapter, "seclusion" means the
8 confinement of a student alone in a room or area from which the
9 student physically is prevented from leaving. The term does not
10 include a supervised time-out or scheduled break, as described in
11 a student's individualized education program, in which an adult is
12 continuously present in the room with the student.

13 Sec. 10. As used in this chapter, "time-out" means a behavior
14 reduction procedure in which access to reinforcement is withdrawn
15 for a certain period of time. Time-out occurs when the ability of a
16 student to receive normal reinforcement in the school environment
17 is restricted. The term does not include a supervised time-out or
18 scheduled break, as described in a student's individualized
19 education program.

20 Sec. 11. (a) The commission on seclusion and restraint in
21 schools is established.

22 (b) The commission has the following ten (10) members:

 - (2) may select school corporations and charter schools that meet the requirements under this chapter to participate in the pilot program.

Sec. 5. (a) To apply for participation in the pilot program, a school corporation or charter school shall do the following:
