 - 8 **IC 36-7.6 of which Wayne County is a member, if the**
 - 9 **commission approves an application under IC 4-33-6.8-7**
 - 10 **to operate an inland casino in Wayne County.**
 - 11 **(2) Forty-five percent (45%) to the city in which the casino**
 - 12 **conducts gaming operations.**
 - 13 **(3) Forty-five percent (45%) to county in which the casino**
 - 14 **conducts gaming operations."**
