**IMPACT:** State & Local

**Summary of Legislation:** (Amended) This bill makes it a Class A misdemeanor for: (1) a person to offer a payment to a public servant as a reward for an official act taken by the public servant; or (2) a public servant to solicit or accept a payment as a reward for an official act performed by the public servant. The bill increases the penalty to a Level 6 felony if the fair market value of the reward is at least \$750.

The bill also exempts: (1) a good or service that is subject to a reporting requirement or otherwise authorized by an applicable rule or code of ethics; (2) a good or service with a value of less than \$100; (3) commemorative or ceremonial items, such as plaques, trophies, or framed photos; (4) lawful political contributions; or (5) wages and other forms of work related compensation from the governmental entity employing the public servant that the public servant is legally permitted to receive.

The bill also provides that a person who knowingly or intentionally violates a specified provision by commingling the funds of a committee with the personal funds of an officer, a member, or an associate of the committee commits a Class A misdemeanor. It enhances the penalty to a Level 6 felony if a person commingles at least \$50,000 of committee funds.

**Effective Date:** July 1, 2026.

**Summary of NET State Impact:** Any impact on state revenue from fines and fees and state expenditures from incarceration costs is expected to be minimal.

**Explanation of State Expenditures:** *Penalty Provision:* A Level 6 felony is punishable by a prison term ranging from 6 to 30 months, with an advisory sentence of 1 year. The sentence depends on mitigating and aggravating circumstances. Assuming offenders can be housed in existing facilities with no additional staff, the marginal cost for medical care, food, and clothing is approximately \$4,825 annually, or \$13.22 daily, per prisoner. However, any additional expenditures are likely to be small.

**Explanation of State Revenues:** *Penalty Provision:* If additional court cases occur and fines are collected, revenue to both the Common School Fund (from fines) and the state General Fund (from court fees) would

increase. The maximum fine for a Class A misdemeanor is \$5,000 and for a Level 6 felony is \$10,000. Total fee revenue per case would range between \$113 and \$138. The amount of court fees deposited will vary depending on whether the case is filed in a court of record or a municipal court. **Explanation of Local Expenditures:** *Penalty Provision:* A Class A misdemeanor is punishable by up to one year in jail. If more defendants are detained in county jails prior to their felony court hearings, local expenditures for jail operations may increase. However, any additional expenditures would likely be small.

**Explanation of Local Revenues:** *Penalty Provision:* If additional court actions result in a guilty verdict, certain local units will collect more revenue.
