## DIGEST OF INTRODUCED BILL

Citations Affected: Noncode.

**Synopsis:** Rape kit processing. Requires the state police department (department) to use part of an appropriation from House Enrolled Act 1001 (2025) to process rape kits and to eliminate the backlog of untested rape kits. Permits the department to issue grants to law enforcement agencies and testing labs to eliminate the backlog of untested rape kits. Requires the department to make a report to the general assembly by October 1, 2027, concerning the status of untested rape kits.

Effective: July 1, 2026.

A BILL FOR AN ACT concerning public safety.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. [EFFECTIVE JULY 1, 2026] (a) Of the eighteen
2	million dollars (\$18,000,000) appropriated to the state police
3	department for forensic and health sciences laboratories in
4	SECTION 4(B) of P.L.213-2025 (HEA 1001-2025) for the state
5	fiscal year beginning July 1, 2026, and ending June 30, 2027, the
6	state police department shall use two million five hundred
7	thousand dollars (\$2,500,000) to process rape kits and to eliminate
8	the backlog of untested rape kits.
9	(b) Funds disbursed under subsection (a) may be used to:
0	(1) purchase equipment, including robots, used to process
1	rape kits;
2	(2) process rape kits;
3	(3) hire staff;
4	(4) provide competitive wages for employees; and
5	(5) pay costs associated with streamlining the processing of
6	rape kits;
7	to eliminate the backlog of untested rape kits.
8	(c) The state police department may make grants to law



1	enforcement agencies and testing labs, including the crime lab
2	within the state police department, to eliminate the backlog of
3	untested rape kits.
4	(d) Before October 1, 2027, the state police department shall
5	report to the general assembly:
6	(1) the status of the backlog of untested rape kits in Indiana;
7	and
8	(2) how funds under subsection (a) were directed to eliminate
9	the backlog of untested rape kits for the prior calendar year.
10	The report to the general assembly must be in an electronic format
11	under IC 5-14-6.
12	(e) This SECTION expires December 31, 2027.
