MR. SPEAKER:

I move that House Bill 1078 be amended to read as follows:

- 1 Page 2, line 14, after "7." insert "(a)".
- 2 Page 3, between lines 6 and 7, begin a new paragraph and insert:
- 3 **"(b) The rules adopted under subsection (a)(14) must include the**
- 4 **following:**
- 5 **(1) Rules requiring a contractor operating a digital**
- 6 **distribution channel for the sale of digital lottery games to:**
- 7 **(A) employ a method to detect the physical location of an**
- 8 **individual who purchases a digital lottery game; and**
- 9 **(B) not accept payment for a digital lottery game from an**
- 10 **individual who is located outside of Indiana.**
- 11 **(2) Rules requiring a contractor operating a digital**
- 12 **distribution channel for the sale of digital lottery games to**
- 13 **verify that an individual who is less than eighteen (18) years**
- 14 **of age does not purchase a digital lottery game.**
- 15 **(3) Rules ensuring that:**
- 16 **(A) the verification process under subdivision (2):**
- 17 **(i) uses commercially reasonable standards; and**
- 18 **(ii) makes a determination based on evidence more**
- 19 **reliable than an individual's attestation; and**
- 20 **(B) information collected during the verification process**
- 21 **under subdivision (2) is kept in a secure manner.**
- 22 SECTION 6. IC 4-30-3-17.5 IS ADDED TO THE INDIANA CODE

1 AS A **NEW SECTION** TO READ AS FOLLOWS [EFFECTIVE JULY
2 1, 2026]: **Sec. 17.5. (a) The commission shall, in cooperation with**
3 **the commission's contractor operating a digital distribution**
4 **channel for the sale of digital lottery games, establish a retailer**
5 **incentive program for retailers that participate in the promotion**
6 **of digital lottery games.**

7 **(b) The commission shall annually do the following at a public**
8 **meeting:**

9 **(1) Review the impact of the sale of online lottery games on**
10 **retailers that sell lottery games.**

11 **(2) Assess whether the retailer incentive program established**
12 **under subsection (a) has been effective in supporting retailer**
13 **participation in the promotion of digital lottery games.**

14 **(3) Recommend changes to the retailer incentive program, if**
15 **the commission finds that the program has not been effective**
16 **under subdivision (2)."**

17 Renumber all SECTIONS consecutively.
