



SENATE MOTION

MR. PRESIDENT:

I move that Engrossed House Bill 1092 be amended to read as follows:

- 1 Page 1, between the enacting clause and line 1, begin a new
2 paragraph and insert:
3 "SECTION 1. IC 4-33-9-13 IS AMENDED TO READ AS
4 FOLLOWS [EFFECTIVE JULY 1, 2026]: Sec. 13. A person who is:
5 **(1) less than twenty-one (21) years of age; or**
6 **(2) delinquent (as defined in IC 4-33-2-5.8);**
7 may not make a wager under this article.
8 SECTION 2. IC 4-33-9-18 IS ADDED TO THE INDIANA CODE
9 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
10 1, 2026]: **Sec. 18. A riverboat gambling facility shall:**
11 **(1) review information made available by the bureau (as**
12 **defined in IC 4-33-2-3.7) each month to determine who is**
13 **delinquent (as defined in IC 4-33-2-5.8); and**
14 **(2) ensure that an individual who is delinquent does not make**
15 **a wager.**
16 SECTION 3. IC 4-35-7-2, AS AMENDED BY P.L.255-2015,
17 SECTION 31, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
18 JULY 1, 2026]: Sec. 2. (a) A person who is:
19 **(1) less than twenty-one (21) years of age; or**
20 **(2) delinquent (as defined in IC 4-33-2-5.8);**
21 may not wager under this article.
22 (b) Except as provided in subsection (c), a person who is less than
23 twenty-one (21) years of age may not be present in the area of a
24 racetrack where gambling games are conducted.
25 (c) A person who is at least eighteen (18) years of age and who is an
26 employee of the racetrack may be present in the area of the racetrack
27 where gambling games are conducted. However, an employee who is

1 less than twenty-one (21) years of age may not perform any function
2 involving gambling by the patrons of the licensee's gambling game
3 facility.
4 SECTION 4. IC 4-35-7-20 IS ADDED TO THE INDIANA CODE
5 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
6 1, 2026]: **Sec. 20. A gambling facility subject to this article shall:**
7 **(1) review information made available by the bureau (as**
8 **defined in IC 4-33-2-3.7) each month to determine who is**
9 **delinquent (as defined in IC 4-33-2-5.8); and**
10 **(2) ensure that an individual who is delinquent does not make**
11 **a wager."**
12 Renumber all SECTIONS consecutively.
