I move that House Bill 1114 be amended to read as follows:

- 1 Page 1, line 3, delete "to a prescription" and insert "**to a:**
2 **(1) prescription drug that is:**
3 **(A) consistent with best practices for the treatment of**
4 **advanced, metastatic cancer or an associated condition;**
5 **(B) supported by peer reviewed, evidence based literature;**
6 **and**
7 **(C) approved by the federal Food and Drug**
8 **Administration; and**
9 **(2) state employee health plan that is established, entered into,**
10 **amended, or renewed after June 30, 2026."**
11 Page 1, delete lines 4 through 9.
12 Page 1, delete lines 14 through 17, begin a new paragraph and
13 insert:
14 **"(c) As used in this section, "associated conditions" means the**
15 **symptoms or side effects directly attributable to advanced,**
16 **metastatic cancer or its treatment, which based on the**
17 **recommendation of a health care practitioner and in accordance**
18 **with documented clinical evidence and generally accepted**
19 **guidelines, would further jeopardize the health of the covered**
20 **individual if left untreated."**
21 Page 2, delete line 1.
22 Page 2, line 19, delete "to a prescription drug" and insert "**to a:**

- 1 **(1) prescription drug that is:**
 2 **(A) consistent with best practices for the treatment of**
 3 **advanced, metastatic cancer or an associated condition;**
 4 **(B) supported by peer reviewed, evidence based literature;**
 5 **and**
 6 **(C) approved by the federal Food and Drug**
 7 **Administration; and**
 8 **(2) policy of accident and sickness insurance that is issued,**
 9 **amended, or renewed after June 30, 2026."**

10 Page 2, delete lines 20 through 25.

11 Page 2, delete lines 30 through 34, begin a new paragraph and
 12 insert:

13 **"(c) As used in this section, "associated conditions" means the**
 14 **symptoms or side effects directly attributable to advanced,**
 15 **metastatic cancer or its treatment, which based on the**
 16 **recommendation of a health care practitioner and in accordance**
 17 **with documented clinical evidence and generally accepted**
 18 **guidelines, would further jeopardize the health of the insured if left**
 19 **untreated."**

20 Page 3, line 8, delete "only" and insert "only to:

- 21 **(1) a prescription drug that is:**
 22 **(A) consistent with best practices for the treatment of**
 23 **advanced, metastatic cancer or an associated condition;**
 24 **(B) supported by peer reviewed, evidence based literature;**
 25 **and**
 26 **(C) approved by the federal Food and Drug**
 27 **Administration; and**
 28 **(2) an individual contract or a group contract that is entered**
 29 **into, amended, or renewed after June 30, 2026."**

30 Page 3, delete lines 9 through 14.

31 Page 3, delete lines 19 through 23, begin a new paragraph and
 32 insert:

33 **"(c) As used in this section, "associated conditions" means the**
 34 **symptoms or side effects directly attributable to advanced,**
 35 **metastatic cancer or its treatment, which based on the**
 36 **recommendation of a health care practitioner and in accordance**
 37 **with documented clinical evidence and generally accepted**
 38 **guidelines, would further jeopardize the health of the enrollee if**
 39 **left untreated."**
