## HOUSE MOTION \_\_\_\_\_

MR. SPEAKER:

I move that House Bill 1119 be amended to read as follows:

1       Page 2, delete lines 14 through 16, begin a new paragraph and  
2       insert:

3       "(c) ~~The warden of the state prison, or persons designated by the~~  
4       ~~warden;~~ shall designate the person who is to serve as the executioner.  
5       **The commissioner of the department of correction shall designate**  
6       **the execution team in the manner prescribed in section 1.5(d) of**  
7       **this chapter. The commissioner of the department of correction**  
8       **shall determine the number of individuals necessary to make up**  
9       **the execution team.**".

10      Page 3, delete lines 28 through 31, begin a new paragraph and  
11      insert:

12      "(b) **The execution must be carried out in the largest public**  
13      **venue in Indiana that has a seating capacity of at least fifty**  
14      **thousand (50,000) seats that is available as determined by the**  
15      **department.**

16      (c) **Costs related to the execution, as determined by the**  
17      **department of correction, shall be paid to the department of**  
18      **correction by the county in which the convicted person was**  
19      **sentenced to the punishment of death.**

20      (d) **The commissioner of the department of correction shall**  
21      **select an execution team from volunteer residents of the county in**  
22      **which the crime for which the convicted person was sentenced the**

1 punishment of death occurred. If the commissioner does not  
2 receive volunteers sufficient to carry out the execution by 5 p.m. on  
3 the tenth day before the date the execution is scheduled, the  
4 convicted person's sentence of death is converted to a sentence of  
5 life without parole by operation of law.

6 (e) Prior to being selected for an execution team, under  
7 subsection (d), each proposed member of the execution team shall  
8 be asked to affirm that the proposed member of the execution team  
9 believes the convicted person committed the crime for which the  
10 punishment of death was imposed.

11 (f) The execution team must receive a briefing that summarizes  
12 the crime for which the convicted person was sentenced to death  
13 and the trial which resulted in the conviction as well as adequate  
14 training necessary to carry out the execution.".

15 Page 3, line 32, delete "(d)" and insert "(g)".

16 Page 3, line 34, delete "(e)" and insert "(h)".

17 Page 3, line 35, delete "by the" and insert "**under subsection (d)**."

18 Page 3, line 36, delete "warden of the prison where the execution  
19 will be carried out.".

20 Page 3, line 39, delete "(f)" and insert "(i)".

21 Page 3, line 41, delete "(g)" and insert "(j)".

22 Page 4, line 17, strike "state prison." and insert "**public forum**  
23 **described in section 1.5(b) of this chapter.**".

24 Page 5, delete lines 14 through 16, being a new line block indented  
25 and insert:

26 "2) The person designated by the warden of the state prison and  
27 any assistants who are necessary to assist in the execution. The  
28 execution team."
