## HOUSE BILL No. 1161

A BILL FOR AN ACT to amend the Indiana Code concerning local government.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 5-4-1-1.3 IS ADDED TO THE INDIANA CODE  
2 AS A **NEW SECTION TO READ AS FOLLOWS [EFFECTIVE**  
3 **UPON PASSAGE]: Sec. 1.3. (a) This section applies only to the**  
4 **appointed officer of a political subdivision.**

5 **(b) The appointing authority must provide notice to the**  
6 **appointed officer as provided in IC 36-1-4.5.**

7 SECTION 2. IC 7.1-2-4-21 IS AMENDED TO READ AS  
8 FOLLOWS [EFFECTIVE JULY 1, 2026]: Sec. 21. Removal from  
9 Office. **An appointed member appointed by the board of county**  
10 **commissioners of a county that does not contain a consolidated city**  
11 **serves at the pleasure of the board of county commissioners.** An  
12 appointed member of a local board, **other than a member appointed**  
13 **by the board of county commissioners of a county that does not**  
14 **contain a consolidated city,** may be removed from office only for  
15 good cause. The commission shall give the member a written copy of

1 the charges against ~~him~~ **the member** and shall fix the time, which shall  
 2 not be less than five (5) days thereafter, when the member may appear

 5 removal of an appointed member of a local board. The findings and  
 6 determinations of the commission in respect to a removal shall be final.

7 SECTION 3. IC 8-22-3-6, AS AMENDED BY P.L.134-2005,  
 8 SECTION 7, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
 9 JULY 1, 2026]: Sec. 6. (a) The board members shall be appointed as  
 10 soon as possible after the adoption of an ordinance establishing an  
 11 authority under this chapter. The term of each member starts at noon  
 12 on the day the authority is established, at which time the board  
 13 members shall meet and organize as the board.

14 (b) Members of the board shall be appointed as follows:  
 15 (1) One (1) member for an initial term of one (1) year.  
 16 (2) One (1) for an initial term of two (2) years.  
 17 (3) If a third or fourth appointment is required, one (1) for an  
 18 initial term of three (3) years and one (1) for an initial term of  
 19 four (4) years.  
 20 (4) If a fifth appointment is required, one (1) for an initial term  
 21 of four (4) years.  
 22 (5) If a sixth appointment is necessary, one (1) for an initial term  
 23 of four (4) years.

24 At the expiration of the respective terms, a member or members shall  
 25 be appointed to fill the vacancies caused by the expiration. The  
 26 members so appointed hold office for a term of four (4) years and until  
 27 their successors are appointed and qualified. If the authority was  
 28 established under IC 19-6-3 (before its repeal on April 1, 1980), at the  
 29 expiration of the members' terms the mayor or the board of county  
 30 commissioners shall appoint a member or members to fill the vacancies  
 31 caused by the expiration. The members so appointed hold office for a  
 32 term of three (3) years and until their successors are appointed and  
 33 qualified.

34 (c) If a vacancy occurs in the board by resignation or otherwise, a  
 35 member shall be appointed for the remainder of the term.

36 (d) A board member is eligible for reappointment to successive  
 37 terms.

38 (e) A board member may be impeached under the procedure  
 39 provided for the impeachment of county officers. **In addition, board**  
 40 **members appointed by a county executive serve at the pleasure of**  
 41 **the county executive.**



1           SECTION 4. IC 8-22-3-6.1 IS AMENDED TO READ AS  
2           FOLLOWS [EFFECTIVE JULY 1, 2026]: Sec. 6.1. (a)  
3           Notwithstanding section 6 of this chapter, the board members of an  
4           authority established under section 1.1 of this chapter shall be  
5           appointed on or before June 15, 1985. The term of each member starts  
6           at noon on the day the authority is established, at which time the board  
7           members shall meet and organize as the board.

8           (b) Members of the board shall be appointed as follows: two (2)  
9           members for an initial term of one (1) year, two (2) members for an  
10           initial term of two (2) years, and two (2) members for an initial term of  
11           three (3) years. At the expiration of the respective terms, a member or  
12           members shall be appointed to fill the vacancies caused by the  
13           expiration. The members so appointed shall hold office for a term of  
14           four (4) years and until their successors are appointed and qualified.

15           (c) If a vacancy occurs in the board by resignation or otherwise, a  
16           member shall be appointed for the remainder of the term.

17           (d) A board member is eligible for reappointment to successive  
18           terms.

19           (e) A board member may be impeached under the procedure  
20           provided for the impeachment of county officers. **In addition, board**  
21           **members appointed by a county executive serve at the pleasure of**  
22           **the county executive.**

23           SECTION 5. IC 11-12-2-2, AS AMENDED BY P.L.86-2017,  
24           SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
25           JULY 1, 2026]: Sec. 2. (a) To qualify for financial aid under this  
26           chapter, a county must establish a community corrections advisory  
27           board by resolution of the county executive or, in a county having a  
28           consolidated city, by the city-county council. A community corrections  
29           advisory board consists of:

- 30           (1) the county sheriff or the sheriff's designee;
- 31           (2) the prosecuting attorney or the prosecuting attorney's  
32           designee;
- 33           (3) the executive of the most populous municipality in the county  
34           or the executive's designee;
- 35           (4) two (2) judges having criminal jurisdiction, if available,  
36           appointed by the circuit court judge or the judges' designees;
- 37           (5) one (1) judge having juvenile jurisdiction, appointed by the  
38           circuit court judge;
- 39           (6) one (1) public defender or the public defender's designee, if  
40           available, or one (1) attorney with a substantial criminal defense  
41           practice appointed by the county executive or, in a county having

2 (7) one (1) victim, or victim advocate if available, appointed by  
3 the county executive or, in a county having a consolidated city,

20 council:  
21 (A) One (1) member of the county fiscal body or the

25 (D) One (1) educational administrator.  
26 (E) One (1) representative of a private correctional agency,  
27 if such an agency exists in the county.  
28 (F) One (1) mental health administrator, or, if there is none  
29 available in the county, one (1) psychiatrist, psychologist,  
30 or physician.  
31 (G) Four (4) lay persons, at least one (1) of whom must be  
32 a member of a minority race if a racial minority resides in  
33 the county and a member of that minority is willing to serve.  
34 (b) Designees of officials designated under subsection (a)(1)  
35 through (a)(6), (a)(9), and (a)(12)(A) serve at the pleasure of the  
36 designating official.  
37 (c) Members of the advisory board appointed by the county  
38 executive or, in a county having a consolidated city, by the city-county  
39 council, shall be appointed for a term of four (4) years. **In addition,**  
40 **members appointed by the county executive of a county that does**  
41 **not contain a consolidated city under this section serve at the**

1       **pleasure of the county executive.** The criminal defense attorney, the  
 2       ex-offender, and the victim or victim advocate shall be appointed for  
 3       a term of four (4) years. Other members serve only while holding the  
 4       office or position held at the time of appointment. The circuit court  
 5       judge may fill the position of the judge having juvenile court  
 6       jurisdiction by self appointment if the circuit court judge is otherwise  
 7       qualified. A vacancy occurring before the expiration of the term of  
 8       office shall be filled in the same manner as original appointments for  
 9       the unexpired term. Members may be reappointed.

10       (d) Two (2) or more counties, by resolution of their county  
 11       executives or, in a county having a consolidated city, by the city-county  
 12       council, may combine to apply for financial aid under this chapter. If  
 13       counties so combine, the counties may establish one (1) community  
 14       corrections advisory board to serve these counties. This board must  
 15       contain the representation prescribed in subsection (a), but the  
 16       members may come from the participating counties as determined by  
 17       agreement of the county executives or, in a county having a  
 18       consolidated city, by the city-county council.

19       (e) The members of the community corrections advisory board  
 20       shall, within thirty (30) days after the last initial appointment is made,  
 21       meet and elect one (1) member as chairman and another as vice  
 22       chairman and appoint a secretary-treasurer who need not be a member.  
 23       A majority of the members of a community corrections advisory board  
 24       may provide for a number of members that is:

25               (1) less than a majority of the members; and  
 26               (2) at least six (6);

27       to constitute a quorum for purposes of transacting business. The  
 28       affirmative votes of at least five (5) members, but not less than a  
 29       majority of the members present, are required for the board to take  
 30       action. A vacancy in the membership does not impair the right of a  
 31       quorum to transact business.

32       (f) The county executive and county fiscal body shall provide  
 33       necessary assistance and appropriations to the community corrections  
 34       advisory board established for that county. Appropriations required  
 35       under this subsection are limited to amounts received from the  
 36       following sources:

37               (1) Department grants.  
 38               (2) User fees.  
 39               (3) Other funds as contained within an approved plan.

40       Additional funds may be appropriated as determined by the county  
 41       executive and county fiscal body.

 2 FOLLOWS [EFFECTIVE JULY 1, 2026]: Sec. 8. **(a) A member of a**  
 3 **local board of health appointed by a county executive of a county**  
 4 **that does not contain a consolidated city serves at the pleasure of**  
 5 **the county executive.**

6 **(b) In addition, any** A member of a local board of health may be  
 7 removed by the **board member's** appointing authority if the board  
 8 member does any of the following:

9 (1) Is absent from three (3) consecutive regular board meetings.  
 10 (2) Is absent from four (4) regular board meetings during a  
 11 calendar year.  
 12 (3) Fails to perform the statutory duties of the office.

13 SECTION 7. IC 33-40-7-3, AS AMENDED BY P.L.111-2024,  
 14 SECTION 11, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
 15 JULY 1, 2026]: Sec. 3. (a) A county executive may adopt an ordinance  
 16 establishing a county public defender board consisting of three (3)  
 17 members. The county executive shall appoint one (1) member. The  
 18 judges who exercise felony or juvenile jurisdiction in the county shall  
 19 appoint by majority vote one (1) member. The Indiana commission on  
 20 court appointed attorneys shall appoint one (1) member who must be  
 21 a resident of the county or region managing the public defender's  
 22 office.

23 (b) The members must be persons who have demonstrated an  
 24 interest in high quality legal representation for indigent persons.  
 25 However, a member may not be:

26 (1) a city, town, or county attorney;  
 27 (2) a law enforcement officer;  
 28 (3) a judge;  
 29 (4) a court employee;  
 30 (5) an attorney who provides representation to indigent persons  
 31 in the county or region managed by the public defender board;  
 32 (6) an employee of the department of child services; or  
 33 (7) an employee of any individuals described in subdivisions (1)  
 34 through (6).

35 (c) Each member of the board serves a three (3) year term  
 36 beginning with the date of the member's appointment. A member  
 37 appointed to fill a vacancy holds office for the remainder of the  
 38 previous member's term. **Each member appointed by a county**  
 39 **executive serves at the pleasure of the county executive.** If a  
 40 successor has not been appointed by the end of a member's three (3)  
 41 year term, the member continues in office until the member's successor



1        takes office. In the case of a county public defender board established  
2        before July 1, 2019, the appointment by the Indiana commission on  
3        court appointed attorneys shall begin upon the first expiration of a

12        (f) A county executive may terminate the board by giving at least  
13        ninety (90) days written notice to the judges described in subsection

15        SECTION 8. IC 33-40-7-3.5, AS AMENDED BY P.L.111-2024,  
16        SECTION 12, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
17        JULY 1, 2026]: Sec. 3.5. (a) A county executive may adopt an  
18        ordinance allowing the county to enter into an interlocal agreement (as  
19        described in IC 36-1-7-3) with one (1) or more counties for the purpose  
20        of:

21        (1) creating a multicounty public defender's office; and  
22        (2) providing legal defense services to indigent persons located  
23        in the counties served by the multicounty public defender's  
24        office.

25        (b) An agreement described in subsection (a) shall:

26        (1) require any created multicounty public defender's office to be  
27        administered by a joint board (as described in  
28        IC 36-1-7-3(a)(5)(B)); and

29        (2) delegate, to an auditor of one (1) of the constituent counties  
30        comprising the multicounty public defender's office, the duty to  
31        receive, disburse, and account for all monies distributed to the  
32        multicounty public defender's office.

33        (c) Notwithstanding any guidelines and standards adopted by the  
34        Indiana commission on court appointed attorneys under IC 33-40-5-4,  
35        the members of a joint board shall be persons who have demonstrated  
36        an interest in high quality legal representation for indigent persons.

37        (d) Notwithstanding any other law or provision, a member of the  
38        joint board may not be:

39        (1) a city, town, or county attorney;  
40        (2) a law enforcement officer;  
41        (3) a judge;

(2) A form for endorsement of the oath of office. Unless contrary to another statute, endorsement of the oath of office may be on the certificate of appointment.

(3) A statement that IC 5-4-1 requires the individual to do the following not later than thirty (30) days after the individual's term begins:

**(A) Sign an oath of office before a person authorized to administer the oath of office in accordance with Indiana law.**

**(B) File the oath of office with the appropriate county clerk.**

(4) A statement that under IC 5-4-1, the failure of the individual to file the oath of office within the time specified may result in the office becoming vacant.

(5) Any other additional requirement, if any, regarding an oath of office that is imposed under a statute applicable to the specific office.

**Sec. 4. The individual shall file a copy of the oath with the appointing authority.**

SECTION 10. IC 36-2-2-14, AS AMENDED BY P.L.127-2017, SECTION 20, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2026]: Sec. 14. (a) The executive may appoint a county administrator to be the administrative head of the county under the supervision of the executive and to hold office at the pleasure of the executive. The executive may assign any office, position, or duties under its control to the administrator, and may by resolution withdraw any of the powers and duties assigned.

(b) Under the supervision of the executive and with its express authorization by resolution, the administrator may:

(1) assist in the administration and enforcement of policies and resolutions of the executive;

(2) supervise activities of county government subject to the control of the executive;

(3) attend meetings of the executive;

(4) recommend measures for adoption to the executive;

(5) prepare and submit reports that the administrator considers advisable or that the executive requires;

(6) keep the executive fully advised on the financial condition of the county;

(7) prepare and submit a budget for each fiscal year; and

(8) perform other duties that the executive requests by resolution.

 10 term of three (3) years and two (2) shall initially be appointed for a  
 11 term of four (4) years. Each member's term expires on the first Monday  
 12 of January of the second, third, or fourth year, respectively, after the  
 13 year of the member's appointment.

14 (c) ADVISORY. Upon the establishment of a county plan  
 15 commission, the citizen members shall initially be appointed for the  
 16 following terms of office:

- 17 (1) One (1) for a term of one (1) year.
- 18 (2) One (1) for a term of two (2) years.
- 19 (3) One (1) for a term of three (3) years.
- 20 (4) Two (2) for a term of four (4) years.

21 Each member's term expires on the first Monday of January of the first,  
 22 second, third, or fourth year, respectively, after the year of the  
 23 member's appointment.

24 (d) ADVISORY. Upon the establishment of a metropolitan plan  
 25 commission, the citizen members shall initially be appointed for the  
 26 following terms of office:

- 27 (1) Three (3) for a term of one (1) year, one (1) appointed by the  
 28 county legislative body and two (2) by the city executive.
- 29 (2) Two (2) for a term of two (2) years, one (1) by each  
 30 appointing authority.
- 31 (3) Two (2) for a term of three (3) years, one (1) by each  
 32 appointing authority.

33 (e) AREA. If there is one (1) citizen member on the area plan  
 34 commission, the member's initial term of office is one (1) year. If there  
 35 are two (2) citizen members, one (1) shall be appointed for a term of  
 36 one (1) year and one (1) for a term of two (2) years. If there are three  
 37 (3) or more citizen members, one (1) shall be appointed for a term of  
 38 one (1) year, one (1) for a term of two (2) years, one (1) for a term of  
 39 three (3) years, and any remainder for a term of four (4) years. Each  
 40 member's term expires on the first Monday of January of the first,  
 41 second, third, or fourth year, respectively, after the year of the

2 (f) ADVISORY-AREA. A **member of a plan commission**  
 3 **appointed by a county executive serves at the pleasure of the**  
 4 **county executive.** The appointing authority, **other than a county**  
 5 **executive,** may remove a member **appointed by the applicable**  
 6 **appointing authority** from the plan commission for cause. The  
 7 appointing authority **that removes a member for cause** must mail  
 8 notice of the removal, along with written reasons for the removal, to the  
 9 member at the member's residence address. A member who is removed  
 10 may, within thirty (30) days after receiving notice of the removal,  
 11 appeal the removal to the circuit or superior court of the county. The  
 12 court may, pending the outcome of the appeal, order the removal or  
 13 stay the removal of the member.

14 (g) METRO. The appointing authority may remove a citizen  
 15 member from the metropolitan development commission. The  
 16 appointing authority must mail notice of the removal, along with  
 17 written reasons, if any, for the removal, to the member at the member's  
 18 residence address. A member who is removed may not appeal the  
 19 removal to a court or otherwise.
