## COMMITTEE REPORT

### MR. SPEAKER:

*Your Committee on Employment, Labor and Pensions, to which was referred House Bill 1188, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill **be amended** as follows:*

- 1       Page 5, after line 38, begin a new paragraph and insert:
- 2       "SECTION 7. IC 36-8-4.7-2, AS ADDED BY P.L.115-2016,
- 3       SECTION 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 4       JULY 1, 2026]: Sec. 2. As used in this chapter, "appointing authority"
- 5       means:
  - 6       (1) the chief executive officer, board, or other entity of a police
  - 7       department with authority to appoint and hire a member of the police department; **or**
  - 8       (2) the chief executive officer, board, or other entity of a fire department with authority to appoint and hire a member of the fire department;
  - 9       **(3) for purposes of a school resource officer who becomes or**
  - 10      **remains a member of the 1977 fund under IC 36-8-8-3(f) or**

1           **IC 36-8-8-3(g), the governing body of a school corporation or**  
2           **the equivalent for a charter school; or**

3           **(4) for purposes of a school police officer, the governing body**  
4           **of a school corporation or the equivalent for a charter school.**

5           SECTION 8. IC 36-8-4.7-5, AS AMENDED BY P.L.238-2025,

6           SECTION 94, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE

7           JULY 1, 2026]: Sec. 5. (a) Notwithstanding any contrary law, an  
8           appointing authority shall waive any age restriction for a person not  
9           more than forty (40) years and six (6) months of age that applies to the  
10          appointment and hiring of an individual as:

11           (1) a member of the police department; **or**

12           (2) a member of the fire department; **or**

13           **(3) a school resource officer (as defined in IC 36-8-8-2.2);**

14          if the individual meets the requirements of subsection (b).

15           (b) An individual who meets all the following requirements is  
16          entitled to the waiver described in subsection (a):

17           (1) On the date the individual applies to be appointed and hired  
18          as:

19           (A) a member of the police department; **or**

20           (B) a member of the fire department; **or**

21           **(C) a school resource officer (as defined in IC 36-8-8-2.2);**

22          the individual is a veteran who has completed at least twenty (20)  
23          years of military service.

24           (2) The individual received or is eligible to receive a discharge  
25          from the armed forces of the United States under conditions other  
26          than conditions set forth in IC 10-17-12-7.5(2).

27           (3) The individual meets all other requirements for appointment  
28          and hiring as:

29           (A) a member of the police department; **or**

30           (B) a member of the fire department; **or**

31           **(C) a school resource officer (as defined in IC 36-8-8-2.2);**

32          including all physical requirements.

33           (c) An individual who is entitled to the waiver described in  
34          subsection (a) is eligible to become a member of the 1977 fund.

35           SECTION 9. IC 36-8-8-2.1, AS AMENDED BY P.L.135-2024,

36           SECTION 8, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE

37           JULY 1, 2026]: Sec. 2.1. (a) As used in this chapter, "local board"  
38          means the following:

(1) For a unit that established a 1925 fund for its police officers, the local board described in IC 36-8-6-2.

(2) For a unit that established a 1937 fund for its firefighters, the local board described in IC 36-8-7-3.

(3) For a consolidated city that established a 1953 fund for its police officers, the local board described in IC 36-8-7.5-2.

(4) For a unit, other than a consolidated city, that did not establish a 1925 fund for its police officers or a 1937 fund for its firefighters, the local board described in subsection (b) or (c).

(5) For an airport authority, the board of an airport authority.

(6) For a school resource officer, the local board described in subdivisions (1) through (4) that manages the fund established in the unit or the consolidated city in which the:

(A) territory of the school corporation; or

(B) charter school;

is located. However, if more than one (1) local board is applicable under this subdivision, the governing body of the school corporation or the equivalent authority for the charter school that employs or contracts to employ the school resource officer may choose the applicable local board with respect to the school resource officer.

**(7) For a school corporation police department established under IC 20-26-16, a local board designated under section 25 of this chapter.**

(b) If a unit did not establish a 1925 fund for its police officers, a local board shall be composed in the same manner described in IC 36-8-6-2(b). However, if there is not a retired member of the department, no one shall be appointed to that position until such time as there is a retired member.

(c) If a unit did not establish a 1937 fund for its firefighters, a local board shall be composed in the same manner described in IC 36-8-7-3(b). However, if there is not a retired member of the department, no one shall be appointed to that position until such time as there is a retired member.

SECTION 10. IC 36-8-8-2.2, AS ADDED BY P.L.135-2024, SECTION 9, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2026]: Sec. 2.2. As used in this chapter, "school resource officer" ~~has the meaning~~ means a law enforcement officer;

1                   **(1) with sworn authority;**  
2                   **(2) who is trained in school based law enforcement and crisis**  
3                   **response;**  
4                   **(3) who is assigned by a law enforcement agency to work**  
5                   **collaboratively with one (1) or more schools; and**  
6                   **(4) who has satisfied the training requirements** set forth in  
7                   IC 20-26-18.2-1.

8                   **The term does not include a law enforcement officer employed by**  
9                   **a school corporation police department established under**  
10                   **IC 20-26-16.**

11                   SECTION 11. IC 36-8-8-3, AS AMENDED BY P.L.135-2024,  
12                   SECTION 10, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
13                   JULY 1, 2026]: Sec. 3. (a) If a town establishes a board of metropolitan  
14                   police commissioners, or if a town becomes a city, the municipality  
15                   shall participate in the 1977 fund and shall enroll all full-time police  
16                   officers and firefighters in the 1977 fund. However, if a police officer  
17                   or former marshal is a member of the public employees' retirement  
18                   fund, the police officer or former marshal may continue as a member  
19                   of that fund instead of the 1977 fund. Notwithstanding the age  
20                   requirements under section 7(a) of this chapter, a police officer or  
21                   former marshal employed by a municipality at the time the  
22                   municipality enters the 1977 fund under this section shall be a member  
23                   of the 1977 fund unless the police officer or former marshal elects to  
24                   continue as a member of the public employees' retirement fund. A  
25                   person may become a member of the 1977 fund under this subsection  
26                   without meeting the age limitation under section 7(a) of this chapter  
27                   only if the person satisfies:

28                   (1) any aptitude, physical agility, or physical and mental standards  
29                   established by a local board under IC 36-8-3.2; and  
30                   (2) the minimum standards that are:  
31                   (A) adopted by the system board under section 19 of this  
32                   chapter; and  
33                   (B) in effect on the date the person becomes a member of the  
34                   1977 fund.

35                   Credit for prior service of a person who becomes a member of the 1977  
36                   fund under this subsection shall be determined under section 18 or 18.1  
37                   of this chapter. No service credit beyond that allowed under section 18  
38                   or 18.1 of this chapter may be recognized under the 1977 fund.

1       (b) If a unit did not establish a 1937 fund for its firefighters, the unit  
2       may participate in the public employees' retirement fund or it may  
3       participate in the 1977 fund. If a unit established a 1937 fund for its  
4       firefighters, the unit is and shall remain a participant in the 1977 fund.

5       (c) A unit that:  
6           (1) has not established a pension fund for its firefighters; or  
7           (2) is participating in the public employees' retirement fund under  
8           subsection (b);  
9       may participate in the 1977 fund upon approval by the fiscal body,  
10      notwithstanding IC 5-10.3-6-8. A unit that participates in the 1977 fund  
11      under this subsection must comply with section 21 of this chapter.  
12      However, if a police officer or firefighter is a member of the public  
13      employees' retirement fund, the police officer or firefighter may  
14      continue as a member of that fund instead of the 1977 fund.

15       (d) If a unit that participates in the 1977 fund provides longevity  
16      increases, the amount of the longevity increase provided in a year must  
17      be greater than or equal to the amount of the longevity increase  
18      provided in the previous year.

19       (e) An airport authority may participate in the 1977 fund. An airport  
20      authority that participates in the 1977 fund under this subsection must  
21      comply with section 21 of this chapter. However, if a police officer or  
22      firefighter is a member of the public employees' retirement fund, the  
23      police officer or firefighter may continue as a member of that fund  
24      instead of the 1977 fund.

25       (f) A school corporation or charter school that:  
26           (1) employs a school resource officer; or  
27           (2) enters into a contract or memorandum of understanding with  
28           **a local law enforcement agency to employ a school resource**  
29           **officer;**  
30           **(A) local law enforcement agency;**  
31           **(B) private entity; or**  
32           **(C) nonprofit corporation;**  
33           **to employ a school resource officer;**  
34       may **allow the school resource officer to participate in the 1977 fund.**  
35       A school corporation or charter school that **participates in the 1977**  
36       **fund employs a school resource officer** under this subsection or  
37       subsection (g) must comply with section 21.5 of this chapter **and must**  
38       **enter into a contract or memorandum of understanding with a**

1       **local law enforcement agency for the purpose of complying with**  
2       **the reporting and payment requirements under sections 6 and 6.5**  
3       **of this chapter.** However, if a school resource officer is a member of  
4       the public employees' retirement fund, the school resource officer may  
5       continue as a member of that fund instead of the 1977 fund.

6       (g) A school resource officer hired or rehired after June 30, 2024,  
7       who is a member of the 1977 fund shall remain in the 1977 fund.

8       (h) **A school corporation or charter school that establishes a**  
9       **school police department under IC 20-26-16 may participate in the**  
10       **1977 fund. For purposes of this chapter, the term "police officer"**  
11       **includes a school police officer who is a member of a school**  
12       **corporation or charter school police department that participates**  
13       **in the 1977 fund. Notwithstanding the age requirements under**  
14       **section 7(a) of this chapter, a school police officer employed by a**  
15       **school corporation or charter school at the time the school**  
16       **corporation or charter school enters the 1977 fund under this**  
17       **section shall be a member of the 1977 fund unless the school**  
18       **corporation or charter school elects to continue the school police**  
19       **officer as a member of the public employees' retirement fund. A**  
20       **school police officer may become a member of the 1977 fund under**  
21       **this subsection without meeting the age limitation under section**  
22       **7(a) of this chapter only if the school police officer satisfies:**

23       (1) **any aptitude, physical agility, or physical and mental**  
24       **standards established by a local board under IC 36-8-3.2; and**  
25       (2) **the minimum standards that are:**

26       (A) **adopted by the system board under section 19 of this**  
27       **chapter; and**

28       (B) **in effect on the date the school police officer becomes**  
29       **a member of the 1977 fund.**

30       **Credit for prior service of a school police officer who becomes a**  
31       **member of the 1977 fund under this subsection shall be determined**  
32       **under section 18 or 18.1 of this chapter. No service credit beyond**  
33       **that allowed under section 18 or 18.1 of this chapter may be**  
34       **recognized under the 1977 fund.**

35       SECTION 12. IC 36-8-8-7, AS AMENDED BY P.L.102-2023,  
36       SECTION 9, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
37       JULY 1, 2026]: Sec. 7. (a) Subject to IC 36-8-4.7 and except as  
38       provided in subsections (d), (e), (f), (g), (h), (k), (l), and (m), a police

1       officer or a firefighter who:

2               (1) is less than forty (40) years of age; and

3               (2) passes the baseline statewide physical and mental  
4               examinations required under section 19 of this chapter;

5       shall be a member of the 1977 fund and is not a member of the 1925  
6       fund, the 1937 fund, or the 1953 fund.

7               (b) A police officer or firefighter with service before May 1, 1977,  
8       who is hired or rehired after April 30, 1977, may receive credit under  
9       this chapter for service as a police officer or firefighter prior to entry  
10      into the 1977 fund if the employer who rehires the police officer or  
11      firefighter chooses to contribute to the 1977 fund the amount necessary  
12      to amortize the police officer's or firefighter's prior service liability over  
13      a period of not more than thirty (30) years, the amount and the period  
14      to be determined by the system board. If the employer chooses to make  
15      the contributions, the police officer or firefighter is entitled to receive  
16      credit for the police officer's or firefighter's prior years of service  
17      without making contributions to the 1977 fund for that prior service. In  
18      no event may a police officer or firefighter receive credit for prior years  
19      of service if the police officer or firefighter is receiving a benefit or is  
20      entitled to receive a benefit in the future from any other public pension  
21      plan with respect to the prior years of service.

22               (c) Except as provided in section 18 of this chapter, a police officer  
23       or firefighter is entitled to credit for all years of service after April 30,  
24       1977, with the police or fire department of an employer covered by this  
25       chapter.

26               (d) A police officer or firefighter with twenty (20) years of service  
27       does not become a member of the 1977 fund and is not covered by this  
28       chapter, if the police officer or firefighter:

29                       (1) was hired before May 1, 1977;

30                       (2) did not convert under IC 19-1-17.8-7 or IC 19-1-36.5-7 (both  
31                       of which were repealed September 1, 1981); and

32                       (3) is rehired after April 30, 1977, by the same employer.

33               (e) A police officer or firefighter does not become a member of the  
34       1977 fund and is not covered by this chapter if the police officer or  
35       firefighter:

36                       (1) was hired before May 1, 1977;

37                       (2) did not convert under IC 19-1-17.8-7 or IC 19-1-36.5-7 (both  
38                       of which were repealed September 1, 1981);

(4) was made, before February 1, 1979, a member of a 1925, 1937, or 1953 fund.

5 (f) A police officer or firefighter does not become a member of the  
6 1977 fund and is not covered by this chapter if the police officer or  
7 firefighter:

10 (2) did not convert under IC 19-1-17.8-7 or IC 19-1-36.5-7 (both  
11 of which were repealed September 1, 1981);

12 (3) is rehired by the police or fire department of another unit after  
13 December 31, 1981; and

14 (4) is made, by the fiscal body of the other unit after December  
15 31, 1981, a member of a 1925, 1937, or 1953 fund of the other

16 unit.  
17 If the police officer or firefighter is made a member of a 1925, 1937, or

18       1953 fund, the police officer or firefighter is entitled to receive credit  
19       for all the police officer's or firefighter's years of service, including  
20       years before January 1, 1982.

21 (g) As used in this subsection, "emergency medical services" and  
22 "emergency medical technician" have the meanings set forth in  
23 IC 16-18-2-110 and IC 16-18-2-112. A firefighter who:

24 (1) is employed by a unit that is participating in the 1977 fund;  
25 (2) was employed as an emergency medical technician by a  
26 political subdivision wholly or partially within the department's  
27 jurisdiction;

28 (3) was a member of the public employees' retirement fund during  
29 the employment described in subdivision (2); and

30 (4) ceased employment with the political subdivision and was  
31 hired by the unit's fire department due to the reorganization of  
32 emergency medical services within the department's jurisdiction;  
33 shall participate in the 1977 fund. A firefighter who participates in the  
34 1977 fund under this subsection is subject to sections 18 and 21 of this  
35 chapter.

36 (h) A police officer or firefighter does not become a member of the  
37 1977 fund and is not covered by this chapter if the individual was  
38 appointed as:

9 (j) A park ranger who:

10 (1) completed at least the number of weeks of training at the  
11 Indiana law enforcement academy or a comparable law  
12 enforcement academy in another state that were required at the  
13 time the park ranger attended the Indiana law enforcement  
14 academy or the law enforcement academy in another state;  
15 (2) graduated from the Indiana law enforcement academy or a  
16 comparable law enforcement academy in another state; and  
17 (3) is employed by the parks department of a city having a  
18 population of more than one hundred ten thousand (110,000) and  
19 less than one hundred fifty thousand (150,000);  
20 is a member of the fund.

21 (k) Notwithstanding any other provision of this chapter, a police  
22 officer or firefighter:

23 (1) who is a member of the 1977 fund before a consolidation  
24 under IC 36-3-1-5.1 or IC 36-3-1-6.1;  
25 (2) whose employer is consolidated into the consolidated law  
26 enforcement department or the fire department of a consolidated  
27 city under IC 36-3-1-5.1 or IC 36-3-1-6.1; and  
28 (3) who, after the consolidation, becomes an employee of the  
29 consolidated law enforcement department or the consolidated fire  
30 department under IC 36-3-1-5.1 or IC 36-3-1-6.1;  
31 is a member of the 1977 fund without meeting the requirements under  
32 sections 19 and 21 of this chapter.

33 (l) Notwithstanding any other provision of this chapter, if:

34 (1) before a consolidation under IC 8-22-3-11.6, a police officer  
35 or firefighter provides law enforcement services or fire protection  
36 services for an entity in a consolidated city;

37 (2) the provision of those services is consolidated into the law  
38 enforcement department or fire department of a consolidated city.

2                   (3) after the consolidation, the police officer or firefighter  
3                   becomes an employee of the consolidated law enforcement  
4                   department or the consolidated fire department under  
5                   IC 8-22-3-11.6;

6                   the police officer or firefighter is a member of the 1977 fund without  
7                   meeting the requirements under sections 19 and 21 of this chapter.

8                   (m) A police officer or firefighter who is a member of the 1977 fund  
9                   under subsection (k) or (l) may not be:

10                   (1) retired for purposes of section 10 of this chapter; or

11                   (2) disabled for purposes of section 12 of this chapter;

12                   solely because of a change in employer under the consolidation.

13                   (n) Notwithstanding any other provision of this chapter and subject  
14                   to subsection (o), a police officer, **school resource officer**, or  
15                   firefighter who:

16                   (1) is an active member of the 1977 fund with an employer that  
17                   participates in the 1977 fund;

18                   (2) separates from that employer; and

19                   (3) not later than one hundred eighty (180) days after the date of  
20                   the separation described in subdivision (2), becomes employed as  
21                   a full-time police officer, **school resource officer**, or firefighter  
22                   with the same or a second employer that participates in the 1977  
23                   fund;

24                   is a member of the 1977 fund without meeting for a second time the  
25                   age limitation under subsection (a) and the requirements under sections  
26                   19 and 21 of this chapter. A police officer, **school resource officer**, or  
27                   firefighter to whom this subsection applies is entitled to receive credit  
28                   for all years of 1977 fund covered service as a police officer, **school**  
29                   **resource officer**, or firefighter with all employers that participate in  
30                   the 1977 fund.

31                   (o) The one hundred eighty (180) day limitation described in  
32                   subsection (n)(3) does not apply to a member of the 1977 fund who is  
33                   eligible for reinstatement under IC 36-8-4-11.

34                   (p) Notwithstanding any other provision of this chapter, a veteran  
35                   who is:

36                   (1) described in IC 36-8-4.7; and

37                   (2) employed as a firefighter, **or** police officer, **or** **school**  
38                   **resource officer**;

1       is a member of the 1977 fund.

2           (q) Notwithstanding any other provision of this chapter and except  
3       as provided in subsection (o), a police officer, **school resource officer**,  
4       or firefighter who:

5               (1) is an active member of the 1977 fund with an employer that  
6       participates in the 1977 fund;  
7               (2) separates from that employer; and  
8               (3) more than one hundred eighty (180) days after the date of the  
9       separation described in subdivision (2), becomes employed as a  
10      full-time police officer, **school resource officer**, or firefighter  
11      with the same or a second employer that participates in the 1977  
12      fund;

13       is a member of the 1977 fund without meeting the age limitation under  
14    subsection (a) provided the member can accrue twenty (20) years of  
15    service credit in the 1977 fund by the time the **police officer, school**  
16    **resource officer, or** firefighter becomes sixty (60) years of age. A  
17    police officer, **school resource officer**, or firefighter who participates  
18    in the 1977 fund under this subsection must pass the baseline statewide  
19    physical and mental examination under section 19 of this chapter. A  
20    police officer, **school resource officer**, or firefighter to whom this  
21    subsection applies is entitled to receive credit for all years of 1977 fund  
22    covered service as a police officer, **school resource officer**, or  
23    firefighter with all employers that participate in the 1977 fund.

24       SECTION 13. IC 36-8-8-21.5, AS ADDED BY P.L.135-2024,  
25    SECTION 13, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
26    JULY 1, 2026]: Sec. 21.5. (a) This section applies to a school resource  
27    officer that becomes or remains a member of the 1977 fund under  
28    section 3(f) or 3(g) of this chapter.

29           (b) A school resource officer is a member of the 1977 fund if the  
30       school resource officer:

31               (1) **subject to IC 36-8-4.7-5**, meets the age limitation under  
32       section 7(a) of this chapter;  
33               (2) passes the baseline statewide physical and mental  
34       examinations required under section 19 of this chapter; and  
35               (3) meets the training requirements under IC 20-26-18.2-1.

36           (c) Credit for prior service of a school resource officer who becomes  
37       a member of the 1977 fund under this section shall be determined  
38       under section 18 or 18.1 of this chapter. No service credit beyond that

1        allowed under section 18 or 18.1 of this chapter may be recognized  
2        under the 1977 fund.

3        SECTION 14. IC 36-8-8-25 IS ADDED TO THE INDIANA CODE  
4        AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
5        1, 2026]: Sec. 25. (a) This section applies to a school corporation  
6        police department established under IC 20-26-16.

7        (b) The governing body of one (1) or more school corporations,  
8        or the equivalent for a charter school, may designate either of the  
9        following as the local board for a school corporation police  
10      department:

11      (1) A local board described in section 2.1(a)(1), 2.1(a)(3), or  
12      2.1(a)(4) of this chapter.

13      (2) A board of trustees established under subsection (c).

14      (c) If the governing body of one (1) or more school corporations,  
15      or the equivalent for a charter school, designates a board of  
16      trustees under subsection (b)(2) to serve as the local board, the  
17      following apply:

18      (1) Except as otherwise provided in this subdivision, the board  
19      of trustees must consist of at least seven (7) but not more than  
20      nine (9) trustees, as follows:

21      (A) A school superintendent or the school superintendent's  
22      designee, a school fiscal officer or the school fiscal officer's  
23      designee, and a police chief of a participating school police  
24      department, who are ex officio voting members of the  
25      board of trustees.

26      (B) One (1) retired member of a participating school police  
27      department. However, if there is not a retired member of  
28      a participating school police department, no one shall be  
29      appointed under this subdivision until such time as there  
30      is a retired member.

31      (C) At least three (3) but not more than five (5) active  
32      members of a participating police department.

33      However, for a board of trustees established under this  
34      subsection where there are not sufficient members of a school  
35      police department to appoint a local board of trustees under  
36      this subsection consisting of at least five (5) trustees, the local  
37      board of trustees appointed under this subsection may be  
38      composed of three (3) trustees, those being the superintendent

1       **or the superintendent's designee, the school fiscal officer or**

3       **department chief. The trustees are selected in a manner**  
4       **prescribed by the governing body for a school corporation or**  
5       **the equivalent for a charter school. If the board of trustees**  
6       **will manage two (2) or more school police departments, the**  
7       **members shall be selected in a manner agreed upon by the**  
8       **participating school corporations or charter schools. The**  
9       **trustees shall serve at the pleasure of the appointing**  
10      **authority.**

11      **(2) A majority of all the trustees constitutes a quorum for the**  
12      **transaction of business.**

13      **(3) The trustees receive no pay for their services.**

14      **(4) The board of trustees may make all necessary bylaws for:**

15       **(A) meetings of the trustees;**

16       **(B) all matters connected with the care, preservation, and**  
17       **disbursement of the fund; and**

18       **(C) all other matters connected with the proper execution**  
19       **of this chapter.**

20      **(5) For purposes of IC 36-8-6-3, the school superintendent or**  
21      **the school superintendent's designee described in subdivision**  
22      **(1)(A) is considered the president, and the school fiscal officer**  
23      **or the school fiscal officer's designee described in subdivision**  
24      **(1)(A) is considered the treasurer."**
