- 4 Page 4, line 21, delete "IC 16-34-1-6." and insert "IC 16-34-1-6; **or**".
- 5 Page 4, between lines 21 and 22, begin a new line block indented
- 6 and insert:
 - 7 **"(7) a violation of a person's rights protected by:**
 - 8 **(A) the Constitution of the United States;**
 - 9 **(B) the Constitution of the State of Indiana; or**

 - 11 **Amendment, including:**
 - 12 **(i) Title VI of the federal Civil Rights Act of 1964;**
