



CONFERENCE COMMITTEE REPORT DIGEST FOR EHB 1200

Citations Affected: IC 5-30-2-3; IC 8-14; IC 8-23-9.5; IC 9-18.1-5-12; IC 9-18.5; IC 9-19-12-1; IC 9-21-5-12; IC 9-24; IC 9-28-4-6; IC 24-4-26; IC 35-52-9.1-30.5; IC 36-6-9.

Synopsis: Bureau of motor vehicles. Allows additional license plates issued by the bureau of motor vehicles (bureau) to be designed as a personalized license plate. Provides that a motor vehicle may be equipped with an appropriate, functioning rear view camera that provides the driver a view of the highway for a distance of at least 200 feet to the rear of the vehicle instead of a mirror. Prohibits the Indiana department of transportation from implementing variable speed limits or using electronic variable speed limit signs. Amends the information required to be provided by an applicant for a driver's license or permit. Amends the required age an individual must be to obtain a driver's license from 16 years and 90 days of age to 16 years of age. Requires an individual to demonstrate sufficient proficiency of the English language to operate a commercial motor vehicle. Provides that an individual commits a Level 6 felony if the individual: (1) represents that a false record is a valid commercial driver's license; or (2) does not have proper documentation while driving with a commercial driver's license issued by any jurisdiction other than a state, territory, or possession of the United States. Provides that a business enterprise may not educate, train, or otherwise prepare an individual to operate a commercial motor vehicle if certain circumstances exist. Makes certain changes to the requirements for the issuance of a nondomiciled commercial driver's license and allows for the revocation of an individual's nondomiciled commercial driver's license in certain circumstances. Allows an applicant for a driver's license or permit to take an examination of the individual's ability to read and understand highway signs and the individual's knowledge of Indiana traffic laws by satisfactorily completing an online examination approved by the bureau. Amends the time that an expired driver's license of an individual temporarily residing outside Indiana because of service in the armed forces remains valid. Changes the time for an individual who is 75 years of age or older and renewing a physical credential to provide proof to the bureau that the individual passed an eyesight examination from 30 days to 60 days. Removes the limitation that a renewal identification card cannot be issued by electronic service if the card expired more than 180 days prior to the date of the application for renewal. Provides that an advertisement that violates the prohibition on advertising certain illegal products must be removed from public circulation not later than



October 1, 2026. Amends certain requirements for township capital improvement plans. **(This conference committee report does the following: (1) Adds a provision that was removed in the Senate regarding the supplemental fee for low speed electric and hybrid vehicles. (2) Deletes provisions concerning the suspension of a driver's license due to a failure to provide evidence of financial responsibility. (3) Adds certain provisions from Engrossed Senate Bill 179. (4) Amends the provision regarding the revocation of a nondomiciled commercial driver's license.)**

Effective: Upon passage; July 1, 2023 (retroactive); July 1, 2026; January 1, 2027.

CONFERENCE COMMITTEE REPORT

MR. SPEAKER:

Your Conference Committee appointed to confer with a like committee from the Senate upon Engrossed Senate Amendments to Engrossed House Bill No. 1200 respectfully reports that said two committees have conferred and agreed as follows to wit:

that the House recede from its dissent from all Senate amendments and that the House now concur in all Senate amendments to the bill and that the bill be further amended as follows:

- 1 Delete everything after the enacting clause and insert the following:
- 2 SECTION 1. IC 5-30-2-3 IS ADDED TO THE INDIANA CODE
- 3 AS A **NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY**
- 4 **1, 2023 (RETROACTIVE)]: Sec. 3. A contract may not be awarded**
- 5 **under this article to a progressive design-builder (as defined in**
- 6 **IC 8-23-9.5-10).**
- 7 SECTION 2. IC 8-14-1-4, AS AMENDED BY P.L.173-2025,
- 8 SECTION 7, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 9 JULY 1, 2026]: Sec. 4. (a) The funds allocated to the respective
- 10 counties of the state from the motor vehicle highway account shall
- 11 annually be budgeted as provided by law, and, when distributed shall
- 12 be used for construction, reconstruction, preservation, and maintenance
- 13 of the highways of the respective counties, including highways which
- 14 traverse the streets of incorporated towns, the cost of the repair and
- 15 maintenance of which prior to the tenth day of September, 1932, was
- 16 paid from the county gravel road repair fund excepting where the
- 17 department is charged by law with the maintenance or construction of
- 18 any such highway so traversing such streets. Subject to subsection (b),
- 19 any surplus existing in the funds at the end of the year shall thereafter

1 continue as a part of the highway funds of the said counties and shall
 2 be rebudgeted and used as already provided in this chapter. The
 3 purchase, rental and repair of highway equipment, painting of bridges
 4 and acquisition of grounds for erection and construction of storage
 5 buildings, acquisition of rights of way and the purchase of fuel oil, and
 6 supplies necessary to the performance of construction, reconstruction,
 7 preservation, and maintenance of highways, shall be paid out of the
 8 highway account of the various counties.

9 (b) Except as provided in subsection (c) and section 4.1 of this
 10 chapter, for funds distributed to a county from the motor vehicle
 11 highway account, the county shall use at least fifty percent (50%) of the
 12 money for the construction, reconstruction, and preservation of the
 13 county's highways.

14 (c) This subsection applies to a county containing a consolidated
 15 city. For funds distributed to a county from the motor vehicle highway
 16 account, the county shall use at least sixty-five percent (65%) of the
 17 money for the construction, reconstruction, and preservation of the
 18 county's highways.

19 **(d) A county, including a county containing a consolidated city,**
 20 **may not budget or designate any funds that are distributed to the**
 21 **county from the motor vehicle highway account for a project to be**
 22 **selected by an individual member of the county fiscal body.**

23 SECTION 3. IC 8-14-2-4, AS AMENDED BY P.L.9-2024,
 24 SECTION 292, IS AMENDED TO READ AS FOLLOWS
 25 [EFFECTIVE JULY 1, 2026]: Sec. 4. (a) The state comptroller shall
 26 establish a special account to be called the "local road and street
 27 account" and credit this account monthly with thirty-seven percent
 28 (37%) of the money deposited in the highway, road and street fund.

29 (b) The state comptroller shall distribute to units of local
 30 government money from this account each month. Before making any
 31 other distributions under this chapter, the state comptroller shall
 32 distribute E85 incentive payments to all political subdivisions entitled
 33 to a payment under section 8 of this chapter.

34 (c) After distributing E85 incentive payments required under section
 35 8 of this chapter, the state comptroller shall allocate to each county the
 36 remaining money in this account on the basis of the ratio of each
 37 county's passenger car registrations to the total passenger car
 38 registrations of the state. The state comptroller shall further determine
 39 the suballocation between the county and the cities within the county
 40 as follows:

41 (1) In counties having a population of more than fifty thousand
 42 (50,000), sixty percent (60%) of the money shall be distributed on
 43 the basis of the population of the city or town as a percentage of
 44 the total population of the county and forty percent (40%)
 45 distributed on the basis of the ratio of city and town street mileage
 46 to county road mileage.

47 (2) In counties having a population of fifty thousand (50,000) or
 48 less, twenty percent (20%) of the money shall be distributed on
 49 the basis of the population of the city or town as a percentage of
 50 the total population of the county and eighty percent (80%)
 51 distributed on the basis of the ratio of city and town street mileage

1 to county road mileage.
 2 (3) For the purposes of allocating funds as provided in this
 3 section, towns which become incorporated as a town between the
 4 effective dates of decennial censuses shall be eligible for
 5 allocations upon the effectiveness of a corrected population count
 6 for the town under IC 1-1-3.5.
 7 (4) Money allocated under the provisions of this section to
 8 counties containing a consolidated city shall be credited or
 9 allocated to the department of transportation of the consolidated
 10 city.

11 (d) Each month the state comptroller shall inform the department of
 12 the amounts allocated to each unit of local government from the local
 13 road and street account.

14 **(e) A county, including a county containing a consolidated city,
 15 may not budget or designate any funds that are distributed to the
 16 county from the local road and street account for a project to be
 17 selected by an individual member of the county fiscal body.**

18 SECTION 4. IC 8-23-9.5-0.1 IS ADDED TO THE INDIANA
 19 CODE AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2023 (RETROACTIVE)]: **Sec. 0.1. It is the
 20 intent of the general assembly that this chapter applies only to a
 21 contract for the delivery of a project of the department. This
 22 chapter does not apply to a contract for the delivery of a project of
 23 a public agency (as defined in IC 5-30-1-11).**

25 SECTION 5. IC 8-23-9.5-18, AS ADDED BY P.L.60-2023,
 26 SECTION 2, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 27 JULY 1, 2026]: Sec. 18. (a) Upon approval of the final scoring of the
 28 CMGCs or the PDBs by the commissioner, the department shall enter
 29 into negotiations with the CMGC or PDB with the highest score as
 30 determined under section 17 of this chapter for a contract.

31 (b) If the department is unable to negotiate a contract with the
 32 person with the highest score for an amount of compensation that the
 33 department and the person determine to be fair and reasonable, the
 34 department shall terminate negotiations with that person. The
 35 department or its authorized representative may then undertake
 36 negotiations with the person with the next highest score and continue
 37 in this manner until an agreement is reached or until a determination
 38 is made by the department to reject all proposals submitted under this
 39 chapter.

40 (c) If the department does not receive at least two (2) proposals, the
 41 department may not enter into a contract under this chapter.

42 (d) The department may only enter into a contract for services under

- 9 (1) draws propulsion energy from both an internal combustion
- 10 engine and an energy storage device; and
- 11 (2) employs a regenerative braking system to recover waste
- 12 energy to charge the energy storage device that is providing
- 13 propulsion energy.
- 14 (d) In addition to any other fee required to register an electric
- 15 vehicle under this chapter, the supplemental fee to register an electric
- 16 vehicle is one hundred fifty dollars (\$150). The bureau shall determine
- 17 a new fee amount to take effect as of January 1 of the following year by
- 18 determining the product of the following:
- 19 (1) Before October 1, 2023:
- 20 (A) the fee in effect for the determination year; multiplied by
- 21 (B) the factor determined under IC 6-6-1.6-2(b).
- 22 (2) Before October 1 of each year thereafter:
- 23 (A) the fee in effect for the determination year; multiplied by
- 24 (B) the factor determined under IC 6-6-1.6-3.
- 25 The fee shall be rounded to the nearest dollar.
- 26 (e) In addition to any other fee required to register a hybrid vehicle
- 27 under this chapter, the supplemental fee to register a hybrid vehicle is
- 28 fifty dollars (\$50). The bureau shall determine a new fee amount to
- 29 take effect as of January 1 of the following year by determining the
- 30 product of the following:
- 31 (1) Before October 1, 2023:
- 32 (A) the fee in effect for the determination year; multiplied by
- 33 (B) the factor determined under IC 6-6-1.6-2(b).
- 34 (2) Before October 1 of each year thereafter:
- 35 (A) the fee in effect for the determination year; multiplied by
- 36 (B) the factor determined under IC 6-6-1.6-3.
- 37 The fee shall be rounded to the nearest dollar.
- 38 (f) The fee shall be deposited in the local road and bridge matching
- 39 grant fund established by IC 8-23-30-2.

35 twenty (20) miles per hour without an engineering and traffic
36 investigation.

37 **(e) The Indiana department of transportation may not:**

38 **(1) implement variable speed limits; or**

39 **(2) use electronic variable speed limit signs.**

 21 combination of states in which the individual formerly resided.
 22 (D) Passes the required examinations.
- 23 (4) The individual meets the following conditions:
 24 (A) Is at least eighteen (18) years of age.
 25 (B) Has previously been a nonresident but, at the time of
 26 application, qualifies as an Indiana resident.
 27 (C) Held a valid driver's license, excluding a learner's permit
 28 or the equivalent, from the state or country of prior residence.
 29 (D) Passes the required examinations.
- 30 (5) The individual meets the following conditions:
 31 (A) Is at least eighteen (18) years of age.
 32 (B) Is a person with a disability.
 33 (C) Holds an Indiana learner's permit.
 34 (D) Has successfully completed driver rehabilitation training
 35 by a certified driver rehabilitation specialist recognized by the
 36 bureau.
 37 (E) Passes the required examinations.
- 38 (6) The individual meets the following conditions:
 39 (A) Is at least sixteen (16) years ~~and ninety (90) days~~ of age.
 40 (B) Is a person with a disability.

11 (ii) at least twenty-one (21) years of age; or

12 (C) an individual with valid driving privileges who:

13 (i) is licensed as a driver education instructor under
 14 IC 9-27-6-8 and is working under the direction of a driver
 15 training school described in IC 9-27-6-3(a)(2); or

16 (ii) is a certified driver rehabilitation specialist recognized
 17 by the bureau who is employed through a driver
 18 rehabilitation program.

 47 [EFFECTIVE UPON PASSAGE]: **Sec. 2.7. (a) An individual must be**
 48 **able to demonstrate proficiency of the English language sufficient**
 49 **to:**

50 **(1) converse with the general public;**

- 1 (2) understand highway traffic signs and signals in the English
 2 language;
 3 (3) respond to official inquiries; and
 4 (4) make entries on reports in records;
