DIGEST OF PROPOSED AMENDMENT

Various changes. Removes SECTION 1 of the bill requiring a license branch to round the total of a transaction. Adds language regarding the fee for an alternative color scheme version of a general assembly license plate.

A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.
