DIGEST OF INTRODUCED BILL

Citations Affected: IC 35-50-2-20.

Synopsis: Aggravated speeding. Provides for a penalty enhancement for aggravated speeding committed in the commission of certain offenses.

Effective: July 1, 2026.

HOUSE BILL No. 1211

A BILL FOR AN ACT to amend the Indiana Code concerning criminal law and procedure.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 35-50-2-20 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
3 1, 2026]: **Sec. 20. (a) As used in this section, "aggravated speeding"**
4 **means operating a motor vehicle in excess of:**

5 (1) **one hundred (100) miles per hour; or**

6 (2) **thirty (30) miles per hour greater than the maximum**
7 **posted speed limit.**

8 (b) **As used in this section, "offense" means a felony described**
9 **in IC 35-42-2-2(b)(1)(B) or IC 35-42-2-2(b)(2)(B).**

10 (c) **The state may seek, on a page separate from the rest of the**
11 **charging instrument, to have a person who allegedly committed an**
12 **offense sentenced to an additional fixed term of imprisonment if**
13 **the state can show beyond a reasonable doubt that the person**
14 **knowingly or intentionally committed aggravated speeding in the**
15 **commission of the offense.**

16 (d) **If the person is convicted of the offense in a jury trial, the**
17 **jury shall reconvene to hear evidence in the enhancement hearing.**



1 **If the trial was to the court, or the judgment was entered on a**
2 **guilty plea, the court alone shall hear evidence in the enhancement**
3 **hearing.**
4 **(e) If the jury (if the hearing is by jury) or the court (if the**
5 **hearing is to the court alone) finds that the state has proven beyond**
6 **a reasonable doubt that the person knowingly or intentionally**
7 **committed aggravated speeding in the commission of the offense,**
8 **the court may sentence the person to an additional fixed term of**
9 **imprisonment of not more than five (5) years.**
10 **(f) A sentence imposed under this section shall run consecutively**
11 **to the underlying sentence.**
