DIGEST OF PROPOSED AMENDMENT

Child services matters. Deletes provisions regarding the office of judicial administration online dashboard. Requires the department of child services to release information to the news media regarding a child fatality: (1) only at the request of the news media; and (2) not later than five business days, or 10 business days for complex cases, after receiving a request from the news media regarding the child fatality.

A BILL FOR AN ACT to amend the Indiana Code concerning family law and juvenile law.
