

PROPOSED AMENDMENT

HB 1258 # 1

DIGEST

Firearms. Adds: (1) dangerous possession of a firearm by a child with two priors; and (2) unlawful carrying of a handgun with two priors; to the crimes of violence list. Makes a technical correction.

- 1 Page 23, between lines 22 and 23, begin a new line block indented
2 and insert:

5 **(A) the child has at least two (2) unrelated prior**
6 **convictions under IC 35-47-10-5 or IC 35-47-2-1.5**

8 **(B) the child has at least two (2) unrelated prior**
9 **delinquency adjudications for an act that would be an**
10 **offense under IC 35-47-10-5 or IC 35-47-2-1.5 (unlawful**
11 **carrying of a handgun); or**
12 **(C) the child has at least one (1) unrelated prior:**
13 **(i) conviction under IC 35-47-10-5 or IC 35-47-2-1.5**
14 **(unlawful carrying of a handgun); and**
15 **(ii) delinquency adjudication for an act that would be an**
16 **offense under IC 35-47-10-5 or IC 35-47-2-1.5 (unlawful**
17 **carrying of a handgun).**
18 **(27) Unlawful carrying of a handgun (IC 35-47-2-1.5), if:**
19 **(A) the person has two (2) unrelated prior convictions**
20 **under IC 35-47-2-1.5 or IC 35-47-10-5 (dangerous**
21 **possession of a firearm by a child);**
22 **(B) the person has at least two (2) unrelated prior**
23 **delinquency adjudications for an act that would be an**
24 **offense under IC 35-47-2-1.5 or IC 35-47-10-5 (dangerous**
25 **possession of a firearm by a child); or**
26 **(C) the person has at least one (1) unrelated prior:**
27 **(i) conviction under IC 35-47-2-1.5 or IC 35-47-10-5**

1 **(dangerous possession of a firearm by a child); and**
2 **(ii) delinquency adjudication for an act that would be an**
3 **offense under IC 35-47-2-1.5 or IC 35-47-10-5**
4 **(dangerous possession of a firearm by a child)."**

5 Page 23, line 29, after "in" insert "**section 79 of this chapter**);".

6 Page 23, delete line 30.

7 Page 23, line 35, delete "IC 35-31.5-2-79);" and insert "**section 79**
8 **of this chapter**);".
