



COMMITTEE REPORT

MR. PRESIDENT:

The Senate Committee on Corrections and Criminal Law, to which was referred House Bill No. 1258, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

- 1 Page 23, between lines 22 and 23, begin a new line block indented
2 and insert:
3 **"(26) Dangerous possession of a firearm by a child (IC**
4 **35-47-10-5), if:**
5 **(A) the child has at least two (2) unrelated prior**
6 **convictions under IC 35-47-10-5 or IC 35-47-2-1.5**
7 **(unlawful carrying of a handgun);**
8 **(B) the child has at least two (2) unrelated prior**
9 **delinquency adjudications for an act that would be an**
10 **offense under IC 35-47-10-5 or IC 35-47-2-1.5 (unlawful**
11 **carrying of a handgun); or**
12 **(C) the child has at least one (1) unrelated prior:**
13 **(i) conviction under IC 35-47-10-5 or IC 35-47-2-1.5**
14 **(unlawful carrying of a handgun); and**
15 **(ii) delinquency adjudication for an act that would be an**
16 **offense under IC 35-47-10-5 or IC 35-47-2-1.5 (unlawful**
17 **carrying of a handgun).**
18 **(27) Unlawful carrying of a handgun (IC 35-47-2-1.5), if:**
19 **(A) the person has two (2) unrelated prior convictions**
20 **under IC 35-47-2-1.5 or IC 35-47-10-5 (dangerous**

- 1 **possession of a firearm by a child);**
 2 **(B) the person has at least two (2) unrelated prior**
 3 **delinquency adjudications for an act that would be an**
 4 **offense under IC 35-47-2-1.5 or IC 35-47-10-5 (dangerous**
 5 **possession of a firearm by a child); or**
 6 **(C) the person has at least one (1) unrelated prior:**
 7 **(i) conviction under IC 35-47-2-1.5 or IC 35-47-10-5**
 8 **(dangerous possession of a firearm by a child); and**
 9 **(ii) delinquency adjudication for an act that would be an**
 10 **offense under IC 35-47-2-1.5 or IC 35-47-10-5**
 11 **(dangerous possession of a firearm by a child)."**
 12 Page 23, line 29, after "in" insert "**section 79 of this chapter**);".
 13 Page 23, delete line 30.
 14 Page 23, line 35, delete "IC 35-31.5-2-79);" and insert "**section 79**
 15 **of this chapter**);".
