

HOUSE BILL No. 1278

DIGEST OF INTRODUCED BILL

Citations Affected: IC 25-23-1-20.1.

Synopsis: Nursing education programs. Allows an institution that has been operating an eligible nursing program for at least five years to increase the enrollment in any eligible nursing program at any rate the institution considers appropriate.

Effective: July 1, 2026.

HOUSE BILL No. 1278

A BILL FOR AN ACT to amend the Indiana Code concerning professions and occupations.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 25-23-1-20.1, AS AMENDED BY P.L.148-2023,
2 SECTION 16, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2026]: Sec. 20.1. (a) As used in this section, "eligible
4 associate or bachelor's degree registered nursing program" means ~~an a~~
5 **practical nursing program or an** associate or bachelor's degree
6 registered nursing program that:
7 (1) is accredited by the board; and
8 (2) has an annual rate of successful completion of the National
9 Council Licensure Examination (NCLEX) score of at least eighty
10 percent (80%).
11 (b) As used in this section, "nursing program" means any of the
12 following:
13 (1) A licensed practical nursing program.
14 (2) An associate degree nursing program.
15 (3) A diploma nursing program.
16 (4) A baccalaureate degree nursing program.

7 (d) A nursing program that:
8 (1) is operated by a postsecondary educational institution, as

10 (2) was accredited by the board on a date after June 30, 2020; and
11 (3) has been operating for at least one (1) year;
12 may increase its enrollment rate by not more than one hundred percent
13 (100%).
