DIGEST OF HB 1278 (Updated February 4, 2026 12:33 pm - DI 104)

Citations Affected: IC 21-41; IC 25-23.

Synopsis: Nursing matters; education programs. Requires a state educational institution that offers a two year graduate degree program in mental or behavioral health to evaluate the graduate degree program to determine the feasibility of providing the program in a specifically structured manner to allow full-time students to complete the program within: (1) one year; or (2) five years if the program is combined with a baccalaureate degree program. Requires certain state educational institutions to offer at least one graduate degree program in one or more certain disciplines that is structured to allow full-time students to

Requires certain state educational institutions to report to the commission for higher education (commission) regarding the graduate degree programs. Requires the commission to post the submitted reports on the commission's website. Requires the Indiana State Nurses Association, any time there is a vacancy or expiration of a term on the board of nursing, to recommend to the governor a list of qualified nurses for appointment. (Current law requires the Indiana State Nurses Association to recommend the list when there is a vacancy on the board.) Allows an institution that has been operating an eligible nursing program for at least five years to increase the enrollment in any eligible nursing program at any rate the institution considers appropriate.

ENGROSSED HOUSE BILL No. 1278

A BILL FOR AN ACT to amend the Indiana Code concerning professions and occupations.

Be it enacted by the General Assembly of the State of Indiana:

Sec. 5. The commission for higher education may consider graduate degrees described in section 3 of this chapter completed within the time frame described in section 2 of this chapter for the purposes of the higher educational operating funding outcomes based formula created by the commission for higher education under IC 21-18-16-2.

Sec. 6. This chapter expires July 1, 2033.

SECTION 2. IC 25-23-1-3, AS AMENDED BY P.L.148-2023, SECTION 12, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2026]: Sec. 3. At any time there is a vacancy **or expiration of a term**, the Indiana State Nurses Association shall recommend to the governor a list of qualified nurses for appointment to the board in the number of not less than twice the number of:

(1) nurse vacancies to be filled; or

(2) nurse appointments to be made.

SECTION 3. IC 25-23-1-20.1, AS AMENDED BY P.L.148-2023, SECTION 16, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2026]: Sec. 20.1. (a) As used in this section, "eligible associate or bachelor's degree registered nursing program" means ~~an a~~ **practical nursing program or an** associate or bachelor's degree registered nursing program that:

(1) is accredited by the board; and

(2) has an annual rate of successful completion of the National Council Licensure Examination (NCLEX) score of at least eighty percent (80%).

(b) As used in this section, "nursing program" means any of the following:

(1) A licensed practical nursing program.

(2) An associate degree nursing program.

(3) A diploma nursing program.

(4) A baccalaureate degree nursing program.

(c) An eligible associate degree or bachelor's degree registered nursing program that has been operating for at least five (5) years may increase enrollment in the program at any rate the program considers appropriate. An institution that has been operating an eligible nursing program for at least five (5) years may increase the enrollment in any eligible nursing program at any rate the institution considers appropriate.

- (2) Clinical addiction counseling.**
- (3) Mental health counseling.**
- (4) Marriage and family therapy.**
- (5) School counseling.**
- (6) Counseling.**
- (7) Psychology.**

Sec. 4. (a) Not later than November 1, 2028, each state educational institution shall report to the commission for higher education, in a form prescribed by the commission for higher education, information regarding each graduate degree program that the state educational institution is offering in compliance with section 3 of this chapter.

(b) Not later than November 1, 2032, each state educational institution shall report to the commission for higher education, in a form prescribed by the commission for higher education, the following information for each graduate degree program described in section 3 of this chapter offered by the state educational institution:

- (1) For each of the immediately preceding four (4) academic years, a description of each graduate degree program.**
- (2) The estimated student cost savings of the graduate degree program.**
- (3) For a graduate degree program that allows completion within one (1) year, the number of students:**
 - (A) enrolled in the graduate degree program; and**
 - (B) who completed the graduate degree program on time; for each of the immediately preceding four (4) academic**



years.

(4) For a graduate degree program combined with a baccalaureate degree program that allows for completion within five (5) years, the number of students:

(A) enrolled in the graduate degree program; and

(B) who completed or are on track to complete the graduate degree program on time;

for each of the immediately preceding four (4) academic years.

(5) Any other information requested by the commission for higher education.

(c) The commission for higher education shall post the reports submitted under this section on the commission for higher education's website.

Sec. 5. The commission for higher education may consider graduate degrees described in section 3 of this chapter completed within the time frame described in section 2 of this chapter for the purposes of the higher educational operating funding outcomes based formula created by the commission for higher education under IC 21-18-16-2.

Sec. 6. This chapter expires July 1, 2033.".
