## DIGEST OF PROPOSED AMENDMENT

Simulated sexual conduct. Removes the requirement that simulated sexual conduct is a crime only if it is obscene.

A BILL FOR AN ACT to amend the Indiana Code concerning criminal law and procedure.

*Be it enacted by the General Assembly of the State of Indiana:*

- (2) required to register as a sex or violent offender under IC 11-8-8-5 due to a conviction for murder (IC [ ]35-42-1-1) or voluntary manslaughter (IC [ ]35-42-1-3);

to wear a monitoring device (as described in IC 35-38-2.5-3) that can transmit information twenty-four (24) hours each day regarding a person's precise location, subject to a validated sex offender risk assessment or appropriate violent offender risk assessment, and subject to the amount appropriated to the department for a monitoring program as a condition of lifetime parole.

 3 degrees under subsection (d).

4 (m) A person may not earn educational credit:

5 (1) for a general educational development (GED) diploma if the  
 6 person has previously earned a high school diploma; or  
 7 (2) for a high school diploma if the person has previously earned  
 8 a general educational development (GED) diploma.

9 (n) A person may not earn educational credit under this section if  
 10 the person:

11 (1) commits an offense listed in IC 11-8-8-4.5 while the person  
 12 is required to register as a sex or violent offender under  
 13 IC 11-8-8-7; and

14 (2) is committed to the department of correction after being  
 15 convicted of the offense listed in IC 11-8-8-4.5.

16 (o) For a person to earn educational credit under subsection  
 17 (a)(3)(B) for successfully completing the requirements for a high  
 18 school diploma through correspondence courses, each correspondence  
 19 course must be approved by the department before the person begins  
 20 the correspondence course. The department may approve a  
 21 correspondence course only if the entity administering the course is  
 22 recognized and accredited by the department of education in the state  
 23 where the entity is located.

24 (p) The department of correction shall, before May 1, 2023, submit  
 25 a report to the legislative council, in an electronic format under  
 26 IC 5-14-6, concerning the implementation of the individualized case  
 27 management plan. The report must include the following:

28 (1) The ratio of case management staff to offenders participating  
 29 in the individualized case management plan as of January 1,  
 30 2023.

31 (2) The average number of days awarded to offenders  
 32 participating in the individualized case management plan from  
 33 January 1, 2022, through December 31, 2022.

34 (3) The percentage of the prison population currently  
 35 participating in an individualized case management plan as of  
 36 January 1, 2023.

37 (4) Any other data points or information related to the status of  
 38 the implementation of the individualized case management plan.
