

HOUSE BILL No. 1328

DIGEST OF INTRODUCED BILL

Citations Affected: IC 16-18-2; IC 16-21-20.

Synopsis: Charges for hospital administered drugs. Prohibits a hospital from billing for an administered drug an amount that exceeds the lesser of the following: (1) 120% of the Medicare reimbursement rate for the administered drug. (2) The amount the hospital bills for the administered drug on June 30, 2026. Creates an exception. Requires a hospital to update the Medicare reimbursement rate for an administered drug on January 1 and July 1 of each year.

Effective: July 1, 2026.

HOUSE BILL No. 1328

A BILL FOR AN ACT to amend the Indiana Code concerning health.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 16-18-2-2.5 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
3 1, 2026]: **Sec. 2.5. "Administered drug", for purposes of
4 IC 16-21-20, has the meaning set forth in IC 16-21-20-2.**

5 SECTION 2. IC 16-18-2-223.9 IS ADDED TO THE INDIANA
6 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
7 [EFFECTIVE JULY 1, 2026]: **Sec. 223.9. "Medicare reimbursement
8 rate", for purposes of IC 16-21-20, has the meaning set forth in
9 IC 16-21-20-3.**

10 SECTION 3. IC 16-21-20 IS ADDED TO THE INDIANA CODE
11 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE
12 JULY 1, 2026]:

13 **Chapter 20. Billing for Administered Drugs**

14 **Sec. 1. This chapter does not apply to the following:**

15 **(1) A critical access hospital that meets the criteria under 42
16 CFR 485.601 through 42 CFR 485.647.**
17 **(2) The Medicaid program.**



1 **Sec. 2. As used in this chapter, "administered drug" means a**
2 **drug delivered to the body of a person by injection, infusion,**
3 **ingestion, or any other means.**

4 **Sec. 3. As used in this chapter, "Medicare reimbursement rate"**
5 **refers to the rate the federal Centers for Medicare and Medicaid**
6 **Services pays for a drug or biological product under Medicare Part**
7 **B.**

8 **Sec. 4. (a) Except as provided in subsection (b), a hospital**
9 **licensed under this article may not submit a bill for an**
10 **administered drug in an amount that exceeds the lesser of the**
11 **following:**

12 **(1) One hundred twenty percent (120%) of the Medicare**
13 **reimbursement rate for the administered drug.**

14 **(2) The amount the hospital bills for the administered drug on**
15 **June 30, 2026.**

16 **(b) If the Medicare reimbursement rate for an administered**
17 **drug increases, a hospital may submit a bill for an administered**
18 **drug that exceeds the amount described in subsection (a)(2) only in**
19 **an amount that does not exceed the percentage increase in the**
20 **Medicare reimbursement rate applied to the amount billed by the**
21 **hospital for the drug on June 30, 2026.**

22 **Sec. 5. A hospital shall update the Medicare reimbursement rate**
23 **for each administered drug on:**

24 **(1) January 1; and**

25 **(2) July 1;**

26 **of each year based on the Medicare reimbursement rate published**
27 **by the federal Centers for Medicare and Medicaid Services for the**
28 **most recent calendar quarter.**
