

HOUSE BILL No. 1334

DIGEST OF INTRODUCED BILL

Citations Affected: IC 27-8-11-8; IC 27-13-9-1.

Synopsis: Directory of in network providers. Requires, upon issuance and renewal of a policy, an insurer to provide a directory of providers with which the insurer has entered into a reimbursement agreement to an insured or prospective insured. (Under current law, an insurer may provide a directory of providers to an insured.) Provides that: (1) a directory of providers provided by an insurer must include every provider that has entered into a reimbursement agreement with the insurer; and (2) a list of providers provided by a health maintenance organization must include every provider who provides health care services through the health maintenance organization.

Effective: July 1, 2026.

HOUSE BILL No. 1334

A BILL FOR AN ACT to amend the Indiana Code concerning insurance.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 27-8-11-8, AS ADDED BY P.L.125-2005,
2 SECTION 5, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2026]: Sec. 8. (a) **Upon:**

4 **(1) issuance; and**

5 **(2) each renewal;**

6 **of a policy**, an insurer ~~may~~ **shall** provide to an insured in electronic or
7 paper form a directory of providers with which the insurer has entered
8 into an agreement under section 3 of this chapter. **The insurer shall**
9 **also provide the directory of providers to a prospective insured**
10 **upon request.**

11 (b) An insurer ~~that provides a directory described in subsection (a)~~
12 shall:

13 (1) inform the insured **or prospective insured** that the insured **or**
14 **prospective insured** may request ~~the~~ **a directory described in**
15 **subsection (a)** in paper form; and

16 (2) provide the directory in paper form upon the request of the
17 insured **or prospective insured.**



1 **(c) A directory described in subsection (a) must include every**
2 **provider that has entered into an agreement with the insurer under**

5 SECTION 7, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
6 JULY 1, 2026]: Sec. 1. (a) Upon:

7 (1) the enrollment; and

8 (2) each reenrollment;

9 of a subscriber, a health maintenance organization must provide to the
10 subscriber in electronic or paper form a list of providers who provide
11 health care services through the health maintenance organization. The
12 health maintenance organization must also provide the list of providers
13 in electronic or paper form to a potential enrollee upon request.

14 (b) A health maintenance organization shall:

15 (1) inform a subscriber or potential enrollee that the subscriber or
16 potential enrollee may request a list described in subsection (a) in
17 paper form; and

18 (2) provide the list in paper form upon the request of the
19 subscriber or potential enrollee.

20 **(c) A list described in subsection (a) must include every provider**
21 **who provides health care services through the health maintenance**
22 **organization.**
