DIGEST OF HB 1360 (Updated January 27, 2026 6:23 pm - DI 119)

Citations Affected: IC 5-14; IC 9-26.

Synopsis: Access to public records. Allows a public agency to establish and maintain an electronic portal for submission of public records requests that: (1) incorporates CAPTCHA or an equivalent mechanism for ensuring that a requestor is a human; (2) requires verification of a requestor's physical address; (3) indicates to the public agency whether the requestor is a resident of Indiana; and (4) automatically logs and reports submissions suspected to be automated or to have originated from known sources of phishing or data scraping. Provides that a public agency may decline to respond to a public records request that is submitted to the public agency electronically if the public agency suspects: (1) the request to be data scraping or phishing activity; or (2) that responding to the request electronically may: (A) expose the public agency's electronic systems or data to unauthorized access or alteration; or (B) otherwise jeopardize the

security of the public agency's electronic systems or data. Provides that the public agency must report: (1) the request to which the public agency declined to respond; and (2) the public agency's reason for declining to respond; to the public access counselor not later than seven days after the public agency receives the request. Allows a public agency to collect a supplemental fee for processing public records requests submitted by non-Indiana residents or out-of-state entities. Allows a public agency to give priority in fulfilling public records requests to: (1) Indiana residents; and (2) requests submitted for civic, journalistic, academic, or personal use. Requires public agencies to report to the public access counselor regarding public records requests suspected of being automated, data scraping activity, or phishing activity (suspect public records requests). Provides that the general assembly may establish reasonable and narrowly tailored procedural safeguards to preserve the integrity and availability of public agency resources. Requires the public access counselor to: (1) take specified actions with regard to identifying excessive and suspect public records requests; and (2) include in the public access counselor's annual report: (A) information regarding the volume and nature of public records requests received by public agencies, including information regarding suspect public records requests reported by public agencies; and (B) recommendations to the general assembly regarding statutory or administrative remedies to excessive and suspect public records requests.

A BILL FOR AN ACT to amend the Indiana Code concerning state and local administration.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 5-14-3-2, AS AMENDED BY P.L.64-2023,
2 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2026]: Sec. 2. (a) The definitions set forth in this section apply
4 throughout this chapter.

5 (b) "Copy" includes transcribing by handwriting, photocopying,
6 xerography, duplicating machine, duplicating electronically stored data
7 onto a disk, tape, drum, or any other medium of electronic data storage,
8 and reproducing by any other means.

9 (c) "Criminal intelligence information" means data that has been
10 evaluated to determine that the data is relevant to:

11 (1) the identification of; and

12 (2) the criminal activity engaged in by;

13 an individual who or organization that is reasonably suspected of
14 involvement in criminal activity.

15 (d) "Data scraping" means use of an automated system to
16 extract data from websites and other Internet accessible sources.

17 (e) "Direct cost" means one hundred five percent (105%) of the

28 **(f) (n)** "Patient" has the meaning set out in IC 16-18-2-272(d).

29 **(f) (o)** "Person" means an individual, a corporation, a limited
30 liability company, a partnership, an unincorporated association, or a
31 governmental entity.

32 **(p) "Phishing" means a method of obtaining information**
33 **through fraud in which the sender of a communication**
34 **intentionally misrepresents the identity of the sender in order to**
35 **induce the recipient of the communication to:**

- 36 (1) **divulge the information to the sender; or**
- 37 (2) **take an action that allows the sender access to the**
38 **information.**

39 **(f) (q) "Private university police department" means the police**
40 **officers appointed by the governing board of a private university under**
41 **IC 21-17-5.**

42 **(p) (r) "Provider" has the meaning set out in IC 16-18-2-295(b) and**

5 **(f)** (s) "Public agency", except as provided in section 2.1 of this

(s) (u) "Standard-sized documents" includes all documents that can be mechanically reproduced (without mechanical reduction) on paper sized eight and one-half (8 1/2) inches by eleven (11) inches or eight and one-half (8 1/2) inches by fourteen (14) inches.

24 (t) (v) "Trade secret" has the meaning set forth in IC 24-2-3-2.

(w) "Work product of an attorney" means information compiled by an attorney in reasonable anticipation of litigation. The term includes the attorney's:

35 SECTION 2. IC 5-14-3-3.3 IS ADDED TO THE INDIANA CODE
36 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
37 1, 2026]: **Sec. 3.3. (a) A public agency may establish and maintain**
38 **an electronic portal for submission of public records requests that:**

39 (1) incorporates Completely Automated Public Turing test to
40 tell Computers and Humans Apart (CAPTCHA) or an
41 equivalent mechanism for ensuring that a requestor is a
42 human;



- (2) requires verification of a requestor's physical address;
- (3) indicates to the public agency whether the requestor is a resident of Indiana; and
- (4) automatically logs and reports submissions suspected to be automated or to have originated from known sources of phishing or data scraping.

(b) A public agency may decline to respond to a public records request that is submitted to the public agency electronically if one (1) or more of the following apply:

(1) The public agency suspects the request to be data scraping or phishing activity.

(2) The public agency suspects that responding to the request electronically may:

(A) expose the public agency's electronic systems or data to unauthorized access or alteration; or

(B) otherwise jeopardize the security of the public agency's electronic systems or data.

(c) Not later than seven (7) days after a public agency receives a public records request to which the public agency declines to respond under subsection (b), the public agency shall notify the public access counselor of the request and the reason under subsection (b) for which the public agency has declined to respond to the request.

SECTION 3. IC 5-14-3-4.4, AS AMENDED BY P.L.249-2019, SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2026]: Sec. 4.4. (a) This section applies to a request for a record that the public agency considers to be excepted from disclosure under section 4(b)(1) or 4(b)(25) of this chapter. The public agency may do either of the following:

(1) Deny disclosure of the record or a part of the record. The person requesting the information may appeal the denial under section 9 of this chapter.

(2) Refuse to confirm or deny the existence of the record, regardless of whether the record exists or does not exist, if the fact of the record's existence or nonexistence would reveal information that would:

(A) impede or compromise an ongoing law enforcement investigation or result in danger to an individual's safety, including the safety of a law enforcement officer or a confidential source; or

confidential source, or
(B) reveal information that would have a reasonable likelihood of threatening public safety.



(b) This subsection applies to a request for a record that the public agency considers to be excepted from disclosure under section 4(b)(19) of this chapter. The agency may consult with the governor's security council established by IC 10-19-8.1-2 in formulating a response. The public agency may do either of the following:

6 (1) Deny disclosure of the record or a part of the record. The
7 agency or the counterterrorism and security council shall provide
8 a general description of the record being withheld and of how
9 disclosure of the record would have a reasonable likelihood of
10 threatening public safety by exposing a vulnerability to terrorist
11 attack. The person requesting the information may appeal the
12 denial under section 9 of this chapter.

13 (2) Refuse to confirm or deny the existence of the record
14 regardless of whether the record exists or does not exist, if the fact
15 of the record's existence or nonexistence would reveal information
16 that would have a reasonable likelihood of threatening public

20 (1) within twenty-four (24) hours of receiving the request for a
21 record from a person who:

22 (A) is physically present in the agency office;
23 (B) makes the request by telephone; or
24 (C) requests enhanced access to a document; or

25 (2) within seven (7) days of receiving the request for a record
26 made by mail, **or by facsimile, or through an electronic portal**

40 the agency to permit the person to inspect and copy the record.

41 (f) The court shall determine the matter de novo, with the burden of
42 proof on the public agency to sustain its refusal to confirm or deny the



1 existence of the record. The public agency meets its burden of proof by
2 filing a public affidavit with the court that provides with reasonable
3 specificity of detail, and not simply conclusory statements, the basis of
4 the agency's claim that it cannot be required to confirm or deny the
5 existence of the requested record. If the public agency meets its burden
6 of proof, the burden of proof shifts to the person requesting access to
7 the record. The person requesting access to the record meets the
8 person's burden of proof by proving any of the following:

9 (1) The agency's justifications for not confirming the existence of
10 the record contradict other evidence in the trial record.
11 (2) The agency is withholding the record in bad faith.
12 (3) An official with authority to speak for the agency has
13 acknowledged to the public in a documented disclosure that the
14 record exists. The person requesting the record must prove that
15 the information requested:
16 (A) is as specific as the information previously disclosed; and
17 (B) matches the previously disclosed information.

18 (g) Either party may make an interlocutory appeal of the trial court's
19 determination on whether the agency's refusal to confirm or deny the
20 existence of the record was proper.

21 (h) If the court, after the disposition of any interlocutory appeals,
22 finds that the agency's refusal to confirm or deny was improper, the
23 court shall order the agency to disclose whether the record exists or
24 does not exist. If the record exists and the agency claims that the record
25 is exempt from disclosure under this chapter, the court may review the
26 public record in camera to determine whether any part of the record
27 may be withheld.

28 (i) In an action filed under this section, the court shall award
29 reasonable attorney's fees, court costs, and other reasonable expenses
30 of litigation to the prevailing party if:

31 (1) the plaintiff substantially prevails; or
32 (2) the defendant substantially prevails and the court finds the
33 action was frivolous or vexatious.

34 A plaintiff is eligible for the awarding of attorney's fees, court costs,
35 and other reasonable expenses regardless of whether the plaintiff filed
36 the action without first seeking and receiving an informal inquiry
37 response or advisory opinion from the public access counselor.

1 permitting a governmental entity to inspect public records by means of

5 (j) Except as provided in subsection (k), a public agency may charge
6 a fee, uniform to all purchasers, for providing an electronic map that is
7 based upon a reasonable percentage of the agency's direct cost of
8 maintaining, upgrading, and enhancing the electronic map and for the
9 direct cost of supplying the electronic map in the form requested by the
10 purchaser. If the public agency is within a political subdivision having

39 script to extract or copy electronically stored data that is the subject of
40 a public records request. A school corporation or charter school may
41 not charge a fee for the first five (5) hours required to search for
42 records that are in an electronic format. A school corporation or charter



1 school may charge a search fee for any time spent searching for records
2 that are in an electronic format that exceeds five (5) hours. If the school
3 corporation or charter school charges a search fee, the school
4 corporation or charter school shall charge an hourly fee that does not
5 exceed the lesser of:

6 (1) the hourly rate of the person making the search; or
7 (2) twenty dollars (\$20) per hour.

8 A school corporation or charter school charging an hourly fee under
9 this subsection for searching for records that are in an electronic format
10 may charge only for time that the person making the search actually
11 spends in searching for the records that are in an electronic format. A
12 school corporation or charter school may not charge for computer
13 processing time and may not establish a minimum fee for searching for
14 records that are in an electronic format. A school corporation or charter
15 school shall make a good faith effort to complete a search for records
