



SENATE MOTION

MR. PRESIDENT:

I move that Engrossed House Bill 1417 be amended to read as follows:

- 1 Page 1, line 4, delete "Commission" and insert "**Task Force**".
- 2 Page 1, line 5, delete "'commission'" and insert "'**task force**'".
- 3 Page 1, line 6, delete "commission" and insert "**task force**".
- 4 Page 1, line 7, delete "commission" and insert "**task force**".
- 5 Page 1, line 8, delete "commission" and insert "**task force**".
- 6 Page 2, delete lines 18 through 42, begin a new paragraph and
- 7 insert:
- 8 **"Sec. 3. The task force consists of the following (15) members:**
- 9 **(1) The president pro tempore of the senate, or a designee of**
- 10 **the president pro tempore who is a member of the senate. The**
- 11 **president pro tempore or designee shall serve as a**
- 12 **co-chairperson of the task force.**
- 13 **(2) The minority leader of the senate or a designee of the**
- 14 **minority leader who is a member of the senate.**
- 15 **(3) The speaker of the house of representatives or the**
- 16 **speaker's designee who is a member of the house of**
- 17 **representatives. The speaker or designee shall serve as a**
- 18 **co-chairperson of the task force.**
- 19 **(4) The minority leader of the house of representatives or the**
- 20 **minority leader's designee who is a member of the house of**
- 21 **representatives.**
- 22 **(5) The governor or the governor's designee.**
- 23 **(6) Five (5) members of the Indiana Alliance for Legal Reform**
- 24 **who are:**
- 25 **(A) recommended to the governor by the Indiana Alliance**
- 26 **for Legal Reform; and**
- 27 **(B) appointed by the governor after consultation with the**

1 **Indiana Alliance for Legal Reform.**
2 **Of the members appointed under this subdivision, one (1)**
3 **member must represent small businesses and one (1) member**
4 **must represent health care entities.**
5 **(7) Five (5) members of the Indiana Trial Lawyers**
6 **Association who are:**
7 **(A) recommended to the governor by the Indiana Trial**
8 **Lawyers Association; and**
9 **(B) appointed by the governor after consultation with the**
10 **Indiana Trial Lawyers Association.**
11 **Of the members appointed under this subdivision, one (1)**
12 **member must specialize in medical malpractice litigation."**
13 Page 3, delete lines 1 through 4.
14 Page 3, line 14, delete "commission" and insert "**task force**".
15 Page 3, line 20, delete "commission" and insert "**task force**".
16 Page 3, line 25, delete "commission" and insert "**task force**".
17 Page 3, line 33, delete "commission" and insert "**task force**".
18 Page 3, line 35, delete "commission" and insert "**task force**".
