MR. SPEAKER:

I move that House Bill 1423 be amended to read as follows:

1 Page 1, between the enacting clause and line 1, begin a new
2 paragraph and insert:

3 "SECTION 1. IC 3-5-2.1-93, AS ADDED BY P.L.186-2025,
4 SECTION 6, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
5 UPON PASSAGE]: Sec. 93. "School board office" refers to an elected
6 position on the school board of a school corporation. **The term**
7 **includes an elected position on the Indianapolis public education**
8 **corporation board established by IC 20-25.3-3-2."**

9 Page 10, delete line 42, begin a new paragraph and insert:

10 "**Sec. 2. (a) The corporation is governed by the Indianapolis**
11 **public education corporation board elected under this section.**

12 **(b) The corporation board is comprised of nine (9) members**
13 **who:**

14 **(1) must reside within the geographic boundaries of the school**
15 **city; and**

16 **(2) are elected at large by the eligible voters from all of the**
17 **districts established under IC 20-25-3-4.**

18 **(c) Members of the corporation board shall be nominated and**
19 **elected in the same manner as school board candidates under IC 3.**

20 **Sec. 3. (a) The members of the corporation board shall be**
21 **elected for an initial term at the 2026 general election as follows:**

22 **(1) The five (5) candidates who receive the greatest number of**

1 **votes are elected to a four (4) year term that begins January**
2 **1 after the election.**

3 **(2) The four (4) candidates who receive the next greatest**
4 **number of votes are elected to a two (2) year term that begins**
5 **January 1 after the election.**

6 **(b) The successors of a member elected under subsection (a)**
7 **shall be elected to a four (4) year term at the general election**
8 **immediately preceding the expiration of the member's term.**

9 **(c) A member elected under this section holds office until a**
10 **successor is elected and qualified.**

11 **(d) A vacancy occurs on the corporation board if a member dies,**
12 **resigns, or ceases to be a resident of the school city. The remaining**
13 **members of the corporation board shall by majority vote fill the**
14 **vacancy by appointing a successor from within the boundaries of**
15 **the school city to serve for the balance of the term.".**

16 Page 11, delete lines 1 through 35.

17 Page 13, delete lines 1 through 22.

18 Renumber all SECTIONS consecutively.
