MR. SPEAKER:

I move that House Bill 1423 be amended to read as follows:

- 1       Page 13, line 39, delete "year," and insert "**year and subject to**
- 2       **section 6(b) of this chapter**,".
- 3       Page 14, line 1, delete "County," and insert "**County and the school**
- 4       **city**,".
- 5       Page 14, line 7, delete "and implement".
- 6       Page 14, line 13, after "schools" insert "**that do not opt out under**
- 7       **section 6(b) of this chapter**".
- 8       Page 17, delete lines 34 through 38, begin a new paragraph and
- 9       insert:  
10       "**Sec. 3. (a) The corporation board shall, in collaboration with**  
11       **the school city and authorizers of charter schools described in**  
12       **IC 20-25.3-2-6, create a single school performance framework that**  
13       **applies beginning with the 2028-2029 school year to all**  
14       **participating schools.**".
- 15       Page 18, line 8, after "measures;" delete "and".
- 16       Page 18, between lines 8 and 9, begin a new line double block
- 17       indented and insert:  
18       "**(H) replication of instructional models that are achieving**  
19       **the best results for students; and**".
- 20       Page 18, line 9, delete "(H)" and insert "(I)".
- 21       Page 18, delete lines 11 through 12, begin a new line block indented

1 and insert:

2 **"(3) include both of the following:**

3       **(A) A process to close chronically low performing**  
4       **participating schools.**

5       **(B) A process to close inefficient school buildings."**

6 Page 18, between lines 18 and 19, begin a new paragraph and insert:

7       **"(d) Except as provided under subsection (e), a participating**  
8       **school may not be closed as described in subsection (b)(3)(A) unless**  
9       **the following occurs:**

10       **(1) If the participating school is a charter school, the**  
11       **authorizer of the participating school approves the closure.**

12       **(2) If the participating school is not a charter school, the**  
13       **board of school commissioners approves the closure.**

14       **(e) If an authorizer or the board of school commissioners,**  
15       **whichever is applicable, does not approve the closure of a**  
16       **participating school under subsection (d), the corporation board**  
17       **may appeal to the state board to request that the participating**  
18       **school be closed. Not later than sixty (60) days after receiving an**  
19       **appeal from the corporation board under this subsection, the state**  
20       **board shall approve or decline the closure of the participating**  
21       **school."**

22 Page 18, line 19, delete "(d)" and insert "(f)".

23 Page 18, line 26, delete "2026," and insert "2027,".

24 Page 19, line 6, after "6." insert "(a)".

25 Page 19, between lines 12 and 13, begin a new paragraph and insert:

26       **"(b) A participating school that is a charter school, including a**  
27       **participating innovation network charter school, may elect to opt**  
28       **out of participation in the management and control of school**  
29       **property by the corporation board. If a participating school elects**  
30       **to opt out under this subsection, the:**

31       **(1) corporation board may not manage or control school**  
32       **property owned or leased by the participating school; and**

33       **(2) participating school may not receive any money that is**  
34       **attributable to the following:**

35       **(A) A debt service levy under IC 20-46-7.**

36       **(B) A levy imposed under IC 6-1.1-20 for controlled**  
37       **projects."**

39 20-46-7-0.5(a)(2)(A)".

40 Page 61, line 37, delete "means:" and insert "means the  
41 following:".

1       Page 61, line 38, delete "a school" and insert "**A school**".  
2       Page 61, line 38, delete "IC 20-18-2-16;" and insert "**IC**  
3       **20-18-2-16(a)).**".  
4       Page 61, line 39, delete "the" and insert "**The**".
