

# PROPOSED AMENDMENT

## HB 1423 # 28

### DIGEST

Indianapolis public education corporation. Excludes adult high schools and virtual charter schools. Amends: (1) the terms and membership requirements of the members of the Indianapolis public education corporation board (board); and (2) requirements for the school city and participating schools with regard to the unified transportation plan. Allows the school city to opt out of participation in the management and control of school property by the board. Provides that property tax revenue from a referendum controlled project tax levy that is approved by the voters after March 31, 2026, shall be distributed to the Indianapolis public education corporation. Adds an additional exception to the restrictions regarding contracts. Makes technical corrections.

 2           **school described in clause (A) who were appointed by the**  
 3           **mayor."**

- 29          Page 21, run in lines 15 through 16.
- 30          Page 21, line 17, delete "debt service" and insert "**controlled**  
 31          **project**".
- 32          Page 21, line 19, delete "school city" and insert "**corporation**".
- 33          Page 21, line 20, delete "(c) A referendum debt service" and insert  
 34          **"(b) A referendum controlled project"**.
- 35          Page 21, line 23, after "referendum" delete "debt service" and insert  
 36          **"controlled project tax"**.
- 37          Page 41, line 28, delete "established by" and insert "**appointed**  
 38          **under**".
- 39          Page 51, line 41, delete "established by" and insert "**appointed**
