

# PROPOSED AMENDMENT

## HB 1423 # 12

### DIGEST

Corporation board. Requires the election (instead of the appointment) of the members of the Indianapolis public education corporation board.

- 1       Page 1, between the enacting clause and line 1, begin a new  
2 paragraph and insert:  
3       "SECTION 1. IC 3-5-2.1-93, AS ADDED BY P.L.186-2025,  
4 SECTION 6, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
5 UPON PASSAGE]: Sec. 93. "School board office" refers to an elected  
6 position on the school board of a school corporation. **The term**  
7 **includes an elected position on the Indianapolis public education**  
8 **corporation board established by IC 20-25.3-3-2."**  
9       Page 6, delete lines 15 through 42, begin a new paragraph and  
10 insert:  
11       **"Sec. 2. (a) The corporation is governed by the Indianapolis**  
12 **public education corporation board elected under this section.**  
13       **(b) The corporation board is comprised of nine (9) members**  
14 **who:**  
15           **(1) must reside within the geographic boundaries of the school**  
16           **city; and**  
17           **(2) are elected at large by the eligible voters from all of the**  
18           **districts established under IC 20-25-3-4.**  
19       **(c) Members of the corporation board shall be nominated and**  
20 **elected in the same manner as school board candidates under IC 3.**  
21       **Sec. 3. (a) The members of the corporation board shall be**  
22 **elected for an initial term at the 2026 general election as follows:**  
23           **(1) The five (5) candidates who receive the greatest number of**  
24           **votes are elected to a four (4) year term that begins January**  
25           **1 after the election.**  
26           **(2) The four (4) candidates who receive the next greatest**  
27           **number of votes are elected to a two (2) year term that begins**

1           **January 1 after the election.**

2           **(b) The successors of a member elected under subsection (a)**  
3           **shall be elected to a four (4) year term at the general election**  
4           **immediately preceding the expiration of the member's term.**

5           **(c) A member elected under this section holds office until a**  
6           **successor is elected and qualified.**

7           **(d) A vacancy occurs on the corporation board if a member dies,**  
8           **resigns, or ceases to be a resident of the school city. The remaining**  
9           **members of the corporation board shall by majority vote fill the**  
10          **vacancy by appointing a successor from within the boundaries of**  
11          **the school city to serve for the balance of the term.".**

12          Page 7, delete lines 1 through 8.

13          Page 8, delete lines 18 through 39.

14          Renumber all SECTIONS consecutively.
