13      Representative Haggard is a commercial broker and a small

3       *College;*

4       *Whereas, He is a proud combat veteran, having served in the*  
5       *United States Marine Corps as an AV-8B Harrier aviator for*  
6       *11 years, then transitioning to the Indiana Air National Guard*  
7       *and continuing his reserve service for another 11 years;*

8       *Whereas, During his service, he flew an F-16 Viper and*  
9       *served as the commander of Headquarters Detachment One at*  
10      *Camp Atterbury;*

11      *Whereas, He retired from the service as a lieutenant colonel*  
12      *in 2013;*

13      *Whereas, Throughout his career as a state legislator,*  
14      *Representative Haggard has been an advocate for Indiana*  
15      *veterans and has authored numerous bills supporting veteran*  
16      *services;*

17      *Whereas, Haggard is a loving husband to his wife, Brooke,*  
18      *and a proud father to Isabella, Eleyna, Aidan, and Ian;*

19      *Whereas, Representative Haggard is an active member of the*  
20      *Veterans of Foreign Wars and the American Legion, and he is*
