



# SENATE MOTION

**MR. PRESIDENT:**

**I move** that Senate Bill 1 be amended to read as follows:

1       Page 7, between lines 37 and 38, begin a new paragraph and insert:  
2       "SECTION 10. IC 12-15-1-26 IS ADDED TO THE INDIANA  
3       CODE AS A NEW SECTION TO READ AS FOLLOWS  
4       [EFFECTIVE JULY 1, 2026]: Sec. 26. **The office of the secretary**  
5       **shall post the following information on the office of the secretary's**  
6       **website:**  
7           (1) **The criteria used in determining whether an individual**  
8       **may be considered medically frail under this article.**  
9           (2) **Examples of the notices sent to Medicaid applicants and**  
10       **recipients and an explanation of the meaning and reasoning**  
11       **of the notice.**  
12       SECTION 11. IC 12-15-1-27 IS ADDED TO THE INDIANA  
13       CODE AS A NEW SECTION TO READ AS FOLLOWS  
14       [EFFECTIVE JULY 1, 2026]: Sec. 27. (a) **As used in this section,**  
15       **"office" includes the following:**  
16           (1) **The office of the secretary of family and social services.**  
17           (2) **A managed care organization that has contracted with the**  
18       **office of Medicaid policy and planning under this article.**  
19           (3) **A person that has contracted with:**  
20              (A) **the office of the secretary of family and social services;**  
21              **or**  
22              (B) **a managed care organization described in subdivision**  
23              **(2).**  
24           (b) **The office shall meet the following requirements concerning**  
25       **a notice of termination of Medicaid services for a recipient:**  
26           (1) **The notice must be provided to the recipient:**  
27              (A) **at least twenty-one (21) days before the termination of**  
28       **services is to occur; or**

**(B) if the time frame set forth in clause (A) would result in the loss of federal financial participation, in the maximum time that would allow for federal financial participation for the services.**

**(2) The notice may not include information or references to conditions or requirements of the program that are not being implemented or enforced by the office.**

SECTION 12. IC 12-15-1-28 IS ADDED TO THE INDIANA CODE AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2026]: **Sec. 28. (a) As used in this section, "office" includes the following:**

**(1) The office of the secretary of family and social services.**

**(2) A managed care organization that has contracted with the office of Medicaid policy and planning under this article.**

**(3) A person that has contracted with:**

**(A) the office of the secretary of family and social services;**

or

**(B) a managed care organization described in subdivision (2).**

**(b) In conducting an eligibility redetermination of a recipient, the office may not terminate coverage for a recipient until the office has reviewed all relevant information timely submitted by the recipient for the redetermination.".**

Renumber all **SECTIONS** consecutively.
