- 10 **prepare a report concerning substantiated claims of Medicaid**
- 11 **fraud, waste, and abuse for the three (3) preceding calendar years**
- 12 **by any of the following:**
- 13 (1) **A managed care organization (as defined in**
- 14 **IC 12-7-2-126.9) that contracted with the office of the**
- 15 **secretary of family and social services to provide services**
- 16 **under the Medicaid program during any of the preceding**
- 17 **three (3) calendar years.**
- 18 (2) **A hospital licensed under IC 16-21.**
- 19 (3) **A health facility licensed under IC 16-28.**
- 20 **(b) The office of the secretary of family and social services shall**
- 21 **submit the report required under subsection (a) to the legislative**
- 22 **council in an electronic format under IC 5-14-6.**
- 23 **(c) This SECTION expires December 31, 2027."**
- 24 Renumber all SECTIONS consecutively.
