SENATE BILL No. 15

A BILL FOR AN ACT to amend the Indiana Code concerning family law and juvenile law.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 14-19-3-1, AS AMENDED BY P.L.213-2025,
2 SECTION 130, IS AMENDED TO READ AS FOLLOWS
3 [EFFECTIVE JULY 1, 2026]: Sec. 1. (a) The department may not
4 charge a price of admission to:
5 (1) inpatients of state or federally owned or operated hospitals or
6 institutions and their supervisors;
7 (2) foster families who reside together in the same foster family
8 home licensed under IC 31-27-4;
9 (3) individuals who meet the definition of foster youth set forth
10 in ~~IC 31-9-2-47.3~~; **IC 31-9-2-47.3(a)**; or
11 (4) a Gold Star family member who displays:
12 (A) an Indiana Gold Star family member license plate under
13 IC 9-18.5-33; or
14 (B) a free annual pass;
15 for the use of any property owned or managed by the department for
16 purposes of this article.
17 (b) If necessary, the department may adopt rules concerning the

3 SECTION 2. IC 27-1-22-20.1, AS AMENDED BY P.L.46-2024,
4 SECTION 2, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
5 JULY 1, 2026]: Sec. 20.1. (a) For purposes of this section, an
6 individual is a "foster youth" if:

- 7 (1) the department of child services; or
 - 8 (2) a designee of the department of child services;
- 9 certifies or acknowledges that the individual is a foster youth (as
10 defined by ~~IC 31-9-2-47.3~~ **IC 31-9-2-47.3(a)**).

11 (b) The department of child services established by IC 31-25-1-1
12 shall make available to foster youths and to the public a list, provided
13 by the Insurance Institute of Indiana, identifying insurers that may
14 provide automobile insurance coverage outside the plan described in
15 subsection (c) for a minor without a guardian cosigner. The list of
16 insurers shall be reviewed annually.

17 (c) An assigned risk automobile insurance plan established by
18 insurers under section 20 of this chapter must, subject to the rules of
19 the plan, make automobile insurance available to a foster youth who:

- 20 (1) is at least sixteen (16) years of age and not more than
21 twenty-three (23) years of age; and
- 22 (2) is receiving services from the department of child services.

23 (d) An applicant who is a foster youth is responsible for paying all
24 costs of a policy of automobile insurance issued under subsection (c).
25 A state or local government agency, foster parent, or entity providing
26 services to an applicant under a contract or at the direction of a state or
27 local government agency shall not be required to pay any costs
28 associated with a policy of automobile insurance issued under
29 subsection (c) and shall not be liable for any damages that result from
30 the foster youth's operation of an automobile owned and insured by the
31 foster youth.

34 JULY 1, 2026]: Sec. 3.9. For purposes of section 7 of this chapter,
35 "foster youth" means an individual who is:

- 36 (1) at least sixteen (16) years of age; and
- 37 (2) certified or acknowledged as a foster youth (as defined in
38 ~~IC 31-9-2-47.3~~ **IC 31-9-2-47.3(a)**) by the department of child
39 services or a designee of the department of child services.

1 JULY 1, 2026]: Sec. 47.3. (a) "Foster youth", for purposes of
 2 IC 31-26-4.5, refers to an individual:
 3 (1) who is at least fifteen (15) years of age;
 4 (2) who is not more than twenty-three (23) years of age; and
 5 (3) who:
 6 (A) is adjudicated a child in need of services under
 7 IC 31-34-1; or
 8 (B) was in foster care when the individual became an adult
 9 (as defined by section 7(b) of this chapter).
 10 (b) "Foster youth", for purposes of IC 31-25-2-29, refers to an
 11 individual:
 12 (1) who is at least twelve (12) years of age;
 13 (2) who is not more than twenty-three (23) years of age;
 14 (3) who:
 15 (A) is a child in need of services under IC 31-34-1; or
 16 (B) is receiving collaborative care (as defined in
 17 IC 31-28-5.8-1); and
 18 (4) who is in an out-of-home placement.
 19 SECTION 5. IC 31-25-2-29 IS ADDED TO THE INDIANA
 20 CODE AS A NEW SECTION TO READ AS FOLLOWS
 21 [EFFECTIVE JULY 1, 2026]: Sec. 29. (a) The department shall
 22 collaborate with:
 23 (1) at least one (1) individual who is at least eighteen (18)
 24 years of age and who has lived experience as a child within
 25 the child welfare system;
 26 (2) at least one (1) child placing agency; and
 27 (3) any other person with expertise in older foster youth
 28 services;
 29 to develop and update periodically a statement that describes the
 30 rights and responsibilities of a foster youth and is titled "the foster
 31 youth bill of rights".
 32 (b) The statement required in subsection (a):
 33 (1) must summarize a foster youth's rights and
 34 responsibilities; and
 35 (2) must be:
 36 (A) distributed annually to a foster youth, including in
 37 a translated form for a foster youth with limited English
 38 proficiency;
 39 (B) distributed to a current or prospective foster parent
 40 (as defined in IC 31-9-2-47); and
 41 (C) published on the department's website.
