A BILL FOR AN ACT concerning family law and juvenile law.

*Be it enacted by the General Assembly of the State of Indiana:*

1       SECTION 1. [EFFECTIVE JULY 1, 2026] **(a) The legislative**  
2       **council is urged to assign to an appropriate study committee**  
3       **during the 2026 interim the task of studying the following:**  
4       **(1) Whether grandparent visitation rights should be expanded**  
5       **to include a grandparent who has a demonstrable history of**  
6       **meaningful contact with a child.**  
7       **(2) The petition and civil procedure requirements for**  
8       **expanding grandparent visitation rights.**  
9       **(b) This SECTION expires July 1, 2027.**
