MR. SPEAKER:

I move that Engrossed Senate Bill 76 be amended to read as follows:

- 1           Page 6, between lines 1 and 2, begin a new paragraph and insert:
- 2           "SECTION 1. IC 11-8-11 IS ADDED TO THE INDIANA CODE
- 3           AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE
- 4           UPON PASSAGE]:
- 5           **Chapter 11. Miami Correctional Facility Reporting**
- 6           **Requirements**
- 7           **Sec. 1. For purposes of this chapter, "2025 agreement" refers to**
- 8           **the intergovernmental service 2025 agreement between ICE and**
- 9           **the Miami correctional facility that commences on September 30,**
- 10          **2025, and terminates on September 29, 2027.**
- 11          **Sec. 2. For purposes of this chapter, "ICE" means the United**
- 12          **States Department of Homeland Security, Immigration and**
- 13          **Customs Enforcement.**
- 14          **Sec. 3. For purposes of this chapter, "Miami correctional**
- 15          **facility" means the state correctional facility located in Miami**
- 16          **County.**
- 17          **Sec. 4. Before March 15, 2026, the department shall submit to**
- 18          **the state budget committee a status update report describing the**
- 19          **following:**
- 20                **(1) The amount of money received after September 29, 2025,**
- 21                **and before March 1, 2026, by the state from ICE under the**
- 22                **2025 agreement related to Section 287(g) of the Immigration**

- 1           **and Nationality Act (8 U.S.C. 1357(g)) with regard to the**
- 2           **Miami correctional facility or any other state facility covered**
- 3           **under the 2025 agreement.**
- 4           **(2) The amount of money expended after September 29, 2025,**
- 5           **and before March 1, 2026, by the department or any other**
- 6           **unit of state government on costs related to the housing and**
- 7           **transportation of individuals, or other similar services, as**
- 8           **described in the 2025 agreement.**
- 9           **(3) Any amendments or modifications to the 2025 agreement**
- 10          **that occurred after September 29, 2025, and before March 1,**
- 11          **2026.**

12          **Sec. 5. Before April 15, 2026, and before the fifteenth day of**  
 13          **each month thereafter through the termination of the 2025**  
 14          **agreement, the department shall submit to the state budget**  
 15          **committee a status update report describing the following:**

- 16           **(1) The amount of money received during the previous month**
- 17           **by the state from ICE under the 2025 agreement related to**
- 18           **Section 287(g) of the Immigration and Nationality Act (8**
- 19           **U.S.C. 1357(g)) with regard to the Miami correctional facility**
- 20           **or any other state facility covered under the 2025 agreement.**
- 21           **(2) The amount of money expended during the previous**
- 22           **month by the department or any other unit of state**
- 23           **government on costs related to the housing and transportation**
- 24           **of individuals, or other similar services, as described in the**
- 25           **2025 agreement.**
- 26           **(3) Any amendments or modifications to the 2025 agreement**
- 27           **that occurred during the previous month.**

28          **Sec. 6. This chapter expires December 31, 2027."**

29          Renumber all SECTIONS consecutively.
