## ENGROSSED SENATE BILL No. 112

---

DIGEST OF SB 112 (Updated February 4, 2026 10:54 am - DI 140)

**Citations Affected:** IC 3-5.

**Synopsis:** Candidacy documents. Provides that when an individual files a notice of withdrawal listing an address different from the address on the individual's voter registration record, the individual's signature on the notice of withdrawal constitutes a request to the county voter registration office that the address on the individual's voter registration record be the same as the address on the notice of withdrawal.

**Effective:** July 1, 2026.

## ENGROSSED SENATE BILL No. 112

---

A BILL FOR AN ACT to amend the Indiana Code concerning elections.

*Be it enacted by the General Assembly of the State of Indiana:*

1        SECTION 1. IC 3-5-7-6.3 IS ADDED TO THE INDIANA CODE  
2        AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
3        1, 2026]: **Sec. 6.3. (a) For purposes of this section, "notice of**  
4        **withdrawal" means a document on which an individual:**  
5            **(1) withdraws as a candidate or nominee;**  
6            **(2) provides notice that the individual:**  
7              **(A) will not accept a nomination;**  
8              **(B) is no longer a candidate; or**  
9              **(C) does not wish the individual's name to appear on the**  
10             **ballot as a candidate;**  
11            **(3) provides a written statement under IC 3-8-7-20 requesting**  
12            **that the individual's name be printed as nominated by**  
13            **petition, convention, subsequent petition, or subsequent**  
14            **convention; or**  
15            **(4) provides a written election under IC 3-8-7-21 of which**  
16            **nomination the individual will accept.**  
17        **(b) Whenever an individual files a notice of withdrawal on**

1       **which the individual lists an address that is different from the**  
2       **address set forth on the individual's voter registration record, the**  
3       **individual's signature on the notice of withdrawal constitutes a**  
4       **request to the county voter registration office that the address on**  
5       **the individual's voter registration record be the same as the**  
6       **address the individual uses on the notice of withdrawal.**
