

PROPOSED AMENDMENT

SB 113 # 6

DIGEST

Publication of election results. Requires each county election board to provide to the election division through a module of the computerized list, not later than 14 days after each election, the votes cast for each candidate and on each public question in each precinct at the last election. Requires the election division to promptly publish these election results on the website maintained by the election division. Specifies that the election results must be downloadable in a format that can be imported into standard spreadsheet computer software.

18 (b) The report described in subsection (a) must be transmitted to the
19 election division using the computerized list under IC 3-7-26.3 not later
20 than fourteen (14) days after each election.
21 (c) The election division shall send a copy of each report to the
22 office not later than ten (10) days after receiving the report.
23 **(d) At the same time the county election board submits the**
24 **report under subsection (a), the board shall provide to the election**

1 **division through a module of the computerized list established**
2 **under IC 3-7-26.3 the votes cast for each candidate and on each**
3 **public question in each precinct at the last election preceding the**
4 **submission of the report.**

5 **(e) This subsection applies if the official election results of an**
6 **election are revised following a recount or election contest**
7 **conducted under IC 3-12. Each county election board shall provide**
8 **to the election division through a module of the computerized list**
9 **established under IC 3-7-26.3 the revised votes cast for each**
10 **candidate and on each public question in each precinct not later**
11 **than fourteen (14) days after the certification of the revised**
12 **election results by a court or the state recount commission.**

13 **(f) The election division shall promptly publish election results**
14 **provided under subsection (d) or (e) on the website maintained by**
15 **the election division. The election results published under this**
16 **subsection must be downloadable in a format that can be imported**
17 **into standard spreadsheet computer software."**

18 Renumber all SECTIONS consecutively.
