SENATE BILL No. 119

A BILL FOR AN ACT to amend the Indiana Code concerning criminal law and procedure.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 35-31.5-2-127.7 IS ADDED TO THE INDIANA
2 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
3 [EFFECTIVE JULY 1, 2026]: **Sec. 127.7. "Facility or event that**
4 **provides entertainment or programming primarily directed**
5 **toward a child less than eighteen (18) years of age", or "facility or**
6 **location holding an event that provides entertainment or**
7 **programming primarily directed toward a child less than eighteen**
8 **(18) years of age", means a facility, location, or event for which**
9 **admission, participation, or attendance is restricted by policy or**
10 **practice to children less than eighteen (18) years of age, or to**
11 **children less than eighteen (18) years of age accompanied by a**
12 **parent, guardian, or custodian.**

13 SECTION 2. IC 35-42-4-10, AS AMENDED BY P.L.98-2025,
14 SECTION 3, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
15 JULY 1, 2026]: Sec. 10. (a) As used in this section, "offender against
16 children" means a person who is an offender against children under
17 section 11 of this chapter.

2 person who is a sexually violent predator under IC 35-38-1-7.5.

3 (c) A sexually violent predator or an offender against children who
4 knowingly or intentionally works for compensation or as a volunteer:

5 (1) on school property;

6 (2) at a youth program center;

7 (3) at a public park;

8 (4) as a child care provider (as defined by IC 31-33-26-1);

9 (5) for a child care provider (as defined by IC 31-33-26-1);

10 (6) as a provider of:

11 (A) respite care services and other support services for
12 primary or family caregivers; or

13 (B) adult day care services; ~~or~~

14 (7) in any setting where the sexually violent predator or offender
15 against children:

16 (A) has more than incidental and occasional contact with a
17 child who is not accompanied by the child's parent,
18 guardian, or custodian;

19 (B) has supervisory or disciplinary power over a child; or

20 (C) is expected to touch a child on a more than incidental
21 and occasional basis; **or**

22 **(8) at a facility or event that provides entertainment or**
23 **programming primarily directed toward a child less than**
24 **eighteen (18) years of age;**

25 commits unlawful employment by a sexual predator, a Level 6 felony.
26 However, the offense is a Level 5 felony if the person has a prior
27 unrelated conviction under this section or based on the person's failure
28 to comply with any requirement imposed on an offender under
29 IC 11-8-8.

30 SECTION 3. IC 35-42-4-13, AS AMENDED BY P.L.168-2014,
31 SECTION 74, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
32 JULY 1, 2026]: Sec. 13. (a) This section does not apply to the
33 following:

34 (1) A parent, guardian, or custodian of a child.

35 (2) A person who acts with the permission of a child's parent,
36 guardian, or custodian.

37 (3) A person to whom a child makes a report of abuse or neglect.

38 (4) A person to whom a child reports medical symptoms that
39 relate to or may relate to sexual activity.

40 (b) As used in this section, "sexual activity" means sexual
41 intercourse, other sexual conduct (as defined in IC 35-31.5-2-221.5),
42 or the fondling or touching of the buttocks, genitals, or female breasts.

1 (c) A person at least eighteen (18) years of age who **knowingly or**
 2 **intentionally:**

3 (1) **knowingly or intentionally** communicates with an individual
 4 whom the person believes to be a child less than fourteen (14)
 5 years of age concerning sexual activity with the intent to gratify
 6 the sexual desires of the person or the individual; **or**

7 (2) **engages in a pattern of repeated or continuous contact**
 8 **with an individual the person believes to be less than**

 18 SECTION 18, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 19 JULY 1, 2026]: Sec. 14. (a) As used in this section, "serious sex
 20 offender" means a person required to register as a sex offender under
 21 IC 11-8-8 who is:

22 (1) found to be a sexually violent predator under IC 35-38-1-7.5;

23 or

24 (2) convicted of one (1) or more of the following offenses:

25 (A) Child molesting (IC 35-42-4-3).

26 (B) Child exploitation (IC 35-42-4-4(b) or IC 35-42-4-4(c)).

27 (C) Possession of child sex abuse material (IC 35-42-4-4(d)
 28 or IC 35-42-4-4(e)).

29 (D) Vicarious sexual gratification (IC 35-42-4-5(a) and
 30 IC 35-42-4-5(b)).

31 (E) Performing sexual conduct in the presence of a minor
 32 (IC 35-42-4-5(c)).

33 (F) Child solicitation (IC 35-42-4-6).

34 (G) Child seduction (IC 35-42-4-7).

35 (H) Sexual misconduct with a minor (IC 35-42-4-9).

36 (b) A serious sex offender who knowingly or intentionally enters:

37 (1) school property; **or**

38 (2) a:

39 (A) facility; **or**

40 (B) location holding an event;

4 (b) A person who knowingly or intentionally accesses:

5 (1) a computer system;

6 (2) a computer network; or

7 (3) any part of a computer system or computer network;

8 without the consent of the owner of the computer system or computer
9 network, or the consent of the owner's licensee, commits computer
10 trespass, a Class A misdemeanor.

11 (c) A person who knowingly or intentionally uses a hoarding
12 program to purchase merchandise by means of a computer network
13 commits computer merchandise hoarding, a Class C infraction. A
14 person commits a separate infraction for each item of merchandise
15 purchased. However, the violation is a Class A misdemeanor if the
16 person has a prior unrelated adjudication or conviction for a violation
17 of this section within the previous five (5) years. It is a defense to a
18 prosecution under this subsection that the person used the hoarding
19 program with the permission of the person selling the merchandise.

20 (d) A person who knowingly or intentionally sells, purchases, or
21 distributes a hoarding program commits unlawful distribution of a
22 hoarding program, a Class C infraction. A person commits a separate
23 infraction for each sale, purchase, or distribution of a hoarding
24 program. However, the violation is a Class C misdemeanor if the
25 person has a prior unrelated adjudication or conviction for a violation
26 of this section within the previous five (5) years. It is a defense to a
27 prosecution under this subsection that the hoarding program was sold,
28 purchased, or distributed for legitimate scientific or educational
29 purposes.
