



# COMMITTEE REPORT

## MR. PRESIDENT:

The Senate Committee on Tax and Fiscal Policy, to which was referred Senate Bill No. 142, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

- 1 Page 1, line 4, delete "County Option Consolidation Ordinance" and
- 2 insert "**Delaware County Hospitality Tax Board Consolidation**
- 3 **Ordinance**".
- 4 Page 1, between lines 4 and 5, begin a new paragraph and insert:
- 5 "**Sec. 0.5. This chapter applies only to Delaware County.**".
- 6 Page 1, line 13, delete "a county:" and insert "**the county:**
- 7 **(1) innkeeper's tax imposed under IC 6-9-18; or**
- 8 **(2) food and beverage tax imposed under IC 6-9-21.**".
- 9 Page 1, delete lines 14 through 16.
- 10 Page 2, line 2, delete "a county:" and insert "**the county:**
- 11 **(1) innkeeper's tax imposed under IC 6-9-18; or**
- 12 **(2) food and beverage tax imposed under IC 6-9-21;**
- 13 **into a single consolidated entity as designated in the ordinance to**
- 14 **administer funds received from both of those taxes.**".
- 15 Page 2, delete lines 3 through 7.
- 16 Page 2, line 11, delete "the applicable" and insert "**IC 6-9-18 or**
- 17 **IC 6-9-21.**".
- 18 Page 2, line 12, delete "chapter of this article."
- 19 Page 2, line 36, delete "salary." and insert "**salary or benefits.**".
- 20 Page 3, line 6, delete "applicable innkeeper's tax or food and" and

- 1 insert **"innkeeper's tax imposed under IC 6-9-18 or food and**
  - 2 **beverage tax imposed under IC 6-9-21"**.
  - 3 Page 3, line 7, delete "beverage tax".
  - 4 Page 3, line 9, delete "any provision of another" and insert "**a**
  - 5 **provision of IC 6-9-18 or IC 6-9-21"**.
  - 6 Page 3, line 10, delete "chapter of this article".
  - 7 Page 3, line 12, delete "the applicable" and insert "**IC 6-9-18 or**
  - 8 **IC 6-9-21."**.
  - 9 Page 3, delete line 13.
  - 10 Page 3, line 30, delete "in a" and insert "**in IC 6-9-18, IC 6-9-21,**
  - 11 **another"**.
- (Reference is to SB 142 as introduced.)
