DIGEST OF PROPOSED AMENDMENT

Board membership. Specifies that a quorum consists of a majority of the executive board members from agencies actively participating, and provides that if a vote is a tie, the position for which the chair voted prevails if that position received the affirmative votes of at least four members.

A BILL FOR AN ACT to amend the Indiana Code concerning local government.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 36-8-25.5-1, AS AMENDED BY P.L.16-2025,
2 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2026]: Sec. 1. The following definitions apply throughout this
4 chapter:
5 (1) "Executive board" means the task force executive board
6 established by section 3 of this chapter.
7 (2) "Task force" means the Indiana crime guns task force
8 established by section 2 of this chapter.
9 (3) "Task force area" means one (1) or more of the following
10 counties:
11 (A) Boone County.
12 (B) Hamilton County.
13 (C) Hancock County.
14 (D) Hendricks County.
15 (E) Marion County.
16 (F) Morgan County.
17 (G) Johnson County.
18 (H) Shelby County.
19 (I) Allen County.

 6 JULY 1, 2026]: Sec. 3. (a) The task force executive board is
 7 established to oversee and direct the operations of the task force.

8 (b) The executive board consists of:

9 (1) the chief of police of the Indianapolis metropolitan police
 10 department or the chief's designee, who serves as the chairperson
 11 of the executive board;
 12 (2) the superintendent of the Indiana state police department or
 13 the superintendent's designee, who serves as the vice chairperson
 14 of the executive board; and
 15 (3) a sheriff or chief of police from each department in the task
 16 force area which has assigned an officer to the task force.

17 (c) The executive board shall hold meetings at the call of the
 18 chairperson. The executive board may establish rules governing
 19 meetings.

20 (d) Seven (7) ~~Eight (8)~~ A majority of the executive board
 21 members ~~constitute~~ from agencies actively participating
 22 constitutes a quorum for the transaction of business. Each member
 23 has one (1) vote, and action by the executive board may be taken only
 24 upon the affirmative votes of the majority of attending members. If a
 25 vote is a tie, the position for which the chairperson voted prevails, as
 26 long as that position has received the affirmative votes of at least
 27 ~~four~~ ~~(4)~~ ~~five (5)~~ members.

28 (e) A member of the executive board is not entitled to:

29 (1) the minimum salary per diem provided by IC 4-10-11-2.1(b);
 30 or
 31 (2) reimbursement for traveling and other expenses as provided
